<u>CC1</u> - Mr. Darrell Sudduth, President of the South Alabama Antique Tractor and Engine Club, discussed the origin of the 1900s sawmill which is being donated to Bicentennial Park, the need for a structure at the park to store the sawmill, and sawmill history in Baldwin County.

**<u>CR6</u>** - Chairman Ball noted Staff Recommendation #2 has been removed at the request of the Personnel Director.

Ashley Campbell, Natural Resource Planner, introduced James Howard, new Natural Resource Planner at the Planning Department, and discussed upcoming projects. Mr. Howard said he looks forward to working with the Commissioners and getting started on various projects.

<u>CS3</u> - Commissioner Gruber discussed the importance of supporting the grant proposal by Auburn University which utilizes different techniques for dealing with stormwater issues.

Ms. Campbell discussed the partnership with Auburn University for the Magnolia River Watershed and thanked the Commission for the letter of support to Auburn University for the infiltration swales grant proposal.

Ms. Hazelbaker recognized Aislinn Stone, Chief Compliance Officer, Accounting Managers Dana Lambert and Christie Bezoari, and other County departments for their hard work which resulted in a clean financial audit for fiscal year 2024. Ms. Hazelbaker discussed the financial report being released a month sooner than last year and the goal to produce the annual auditable financials by April 1, 2026.

Mr. Rendleman noted counties are audited for federal as well as state compliance and recognized Wanda Gautney, Purchasing Director, Jeanette Brown, Assistant Purchasing Director, Robin Benson, Accounts Payable Supervisor, and the Accounts Payable Department staff for their diligence in ensuring the County has proper documentation.

GA1 North Baldwin County Health Care Authority - Appointments

Motion by Commissioner Billie Jo Underwood to appoint Commissioner James E. Ball to the North Baldwin County Health Care Authority.

Chairman Ball noted there are other appointments to the North Baldwin County Health Care Authority listed in the staff recommendation of Item GA1.

After Commissioner Gruber read the staff recommendation for Item GA1, Commissioner Underwood restated her motion as follows:

Motion by Commissioner Billie Jo Underwood, seconded by Commissioner Charles F. Gruber, as related to the North Baldwin County Health Care Authority, to take the following actions:

- 1) Due to the expiration of Mr. Dennis Godwin's term on January 1, 2026, appoint Mr. James E. Ball as a member to the place seat (Slot 2) formerly held by Mr. Godwin, for a six (6) year term, said term commencing January 1, 2026, and expiring January 1, 2032; and
- 2) Accept the resignation of Ms. Phyllis French and appoint Ms. Willie "Felisha" Anderson as a member to the place seat (Slot 3) formerly held by Ms. French, for a pro-rata reduced six (6) year term, said term commencing December 2, 2025, and expiring January 1, 2030; and
- 3) Reappoint Mr. Jason Padgett as a member to place seat (Slot 5) for a six (6) year term, said term continuing from January 1, 2026, and expiring January 1, 2032; and
- 4) Accept the resignation of Ms. Lynn Biles and appoint Ms. Karmen Still as a member to the place seat (Slot 8) formerly held by Ms. Biles, for a pro-rata reduced six (6) year term, said term commencing December 2, 2025, and expiring January 1, 2028; and
- 5) Due to the expiration of Mr. Robert Zarr, Sr.'s term on January 1, 2026, appoint Ms. Sarah Davis as a member to the place seat (Slot 9) formerly held by Mr. Zarr, for a six (6) year term, said term commencing January 1, 2026, and expiring January 1, 2032.

After the motion, and before the vote, discussion took place regarding the extent of authority the Baldwin County Commission holds over the boards to which it appoints members.

Brad Hicks, County Attorney, explained the Commission appoints members to certain boards based on State statute and the board governs the entity it presides over, not the County Commission.

Roger Rendleman, County Administrator, discussed limitations to board members' authority, particularly in the context of boards governed by State statute.

Mr. Hicks further discussed the Alabama Legislature giving appointing authority of certain state entities to a local agency and the Commission's role in appointing members

rather than managing boards. Mr. Hicks said the Commission would be exceeding its authority if attempting to manage a board.

Commissioner Gruber noted the North Baldwin County Health Care Authority was created by the Alabama Legislature and the only authority the Commission has is to appoint the board members.

#### I COMMISSIONER COMMENTS

The Commissioners provided their closing comments.

Discussion took place regarding the Commission's authority regarding boards appointed by the Baldwin County Commission, specifically the Baldwin County Board of Human Resources.

Brad Hicks, County Attorney, explained that under the Code of Alabama, the Commission only has the authority to appoint members. It cannot withhold funding or hold authority over the management of State-funded boards. Mr. Hicks noted that to insinuate the Commission has authority over financial or management aspects of a board is a misrepresentation of Alabama law, and anyone with questions regarding the Baldwin County Board of Human Resources should reach out to the State of Alabama Department of Human Resources in Montgomery, Alabama.

Chairman Ball said the Baldwin County Commission has no authority over state agencies such as the Department of Human Resources.
