A part of the East Half of the Northwest Quarter of the Southeast Quarter of Section 32, Township 6 South, Range 5 East, identified as Tract Number 5 on Bemis Lane, Project No. 0221319 in Baldwin County, Alabama and being more fully described as follows:

Commencing at a railroad spike found at the southeast corner of the Southeast Quarter of Section 32, Township 6 South, Range 5 East, in Baldwin County, Alabama;


TO HAVE AND TO HOLD, unto Baldwin County, Alabama, its successors and assigns in fee simple forever.
