## RESOLUTION

- **WHEREAS**, Corporal Tobin attended Baldwin County High School and Mississippi Valley State University where he received numerous athletic awards; and
- **WHEREAS**, Corporal Tobin was inducted into the Mississippi Valley State University Athletic Hall of Fame in April 2022; and
- **WHEREAS**, Corporal Tobin began his law enforcement career in July 1987 as a Deputy Jailer under Sheriff James B. Johnson, and completed the Southwest Alabama Police Academy Peace Officer's Standards and Training Commission in May 1991; and
- **WHEREAS**, Corporal Tobin transferred from the Baldwin County Corrections Center to the Baldwin County Sheriff's Office Patrol Division as a patrol deputy in August of 1995; and
- WHEREAS, Corporal Tobin successfully achieved his goals by serving in various assignments during his career with the Baldwin County Sheriff's Office including SWAT Command, Criminal Investigations Command, Corrections Security, Corrections Support, Supervisor Civil Command, and Supervisor of Sex Offender Compliance; and
- **WHEREAS**, Corporal Tobin has been recognized with various professional accolades including letters from co-workers, supervisors, judges, and citizens; and
  - WHEREAS, Corporal Tobin was promoted to the rank of Corporal in 2005; and
- **WHEREAS**, Corporal Tobin developed a comprehensive amount of knowledge and experience of law enforcement processes which enabled him to be of immense value to the Baldwin County Sheriff's Office, the Corrections Center, and Baldwin County; and
- **WHEREAS**, Corporal Tobin is a member of the Spanish Fort Law Enforcement Foundation; and
- **WHEREAS**, with Corporal Tobin's many accomplishments, over 30 years of law enforcement and service to the public, it is only fitting that this honorable county governing body publicly recognize and commend Corporal Ricky Tobin for his distinguished public service; now therefore
