"Every year we see preventable injuries caused by decorations that people assume are harmless," Brian Chase of Bismar Chase said in a statement. "A broken ornament, a wobbly tree stand or an overloaded outlet doesn't feel like a major threat - until it sends someone to the hospital. Our message is simple: enjoy the season but take those extra seconds to decorate safely. It's the easiest way to keep the holidays joyful instead of painful."

Gulf Shores and Orange Beach typically have relatively quiet Christmases when it comes to injuries or other incidents reported to the police department.

"This time of year is traditionally

slower and we don't see any particular 'trend' each year," Orange Beach Interim Chief of Police Trent Johnson said. "Every so often, we may have a rash of package thefts off porches or unlocked vehicles that are rifled through but for the most part we don't have anything with any semblance of regularity."

Gulf Shores Chief of Police Dan Netemeyer said calls for services are generally down in the holiday season and officers can focus more on crime prevention during this time.

Gulf Coast Media also reached out to Baldwin Health and Infirmary Health but they did not respond before press deadline.
