#### V. NEW BUSINESS

- Update: Intracoastal Waterway Exercise Planning with US Coast Guard  
Tom Tyler (BCEMA) provided an exercise update. He gave a recap of the Intracoastal Waterway exercise history to date and stated that an Initial Planning Meeting is set to take place this month. Further, a tow company and a barge company have been identified for this exercise. Tom re-emphasized that much care is being taken in putting the planning team together because "planners can't be players." Generally, everyone should learn a lot from this experience.
- December Full Body Meeting / Christmas Luncheon Meat Money Allotment  
Chief Darby (Foley Fire) gave a recap of the voting process and discussion that took place in the Steering Committee, as well as the results. Those results were that the Steering Committee approved to spend up to \$400.00 on meat. He then opened the floor for any other discussion or comments. There was none. Chief then opened the floor for a motion. John Wade (LASAR) made a motion to approve spending \$400.00 on meat for the December Full Body Meeting / Christmas Luncheon. Multiple attendees seconded the motion. All present approved. Motion carried.
