General Board Information:

Members appointed by Baldwin County Commission. Eight initial board of director appointments, with each County Commissioner appointing two directors. Term of each initial member shall be four years from the time of incorporation through December 31, 2028. After expiration of initial appointments, all appointments shall be for a period of four years. If a director is removed, the County Commissioner who appointed the removed director shall appoint a new director to fill the vacant position.

Directors must be residents of Baldwin County, Alabama. If a director ceases to be a resident of Baldwin County, such person shall cease to be a director and the position shall remain vacant until a successor is appointed.

Directors shall serve without compensation except for reimbursement for actual expenses incurred in and about the performance of their duties as directors.

May 6, 2025 - Baldwin County Commission authorized the incorporation of "The Industrial Development Authority of Baldwin County" by adoption of Resolution #2025-116 (Agenda Item CA6). The authorized operational area of the IDA shall include all territory within Baldwin County, Alabama. Statutory Authority: Chapter 92A of Title 11 of the Code of Alabama (1975).
