concept that has been in his head for a long time," Robert Evans said.

The team is shooting for an opening in the fourth quarter of this year. Until then, Briand will be working side-by-side with The Hope Farm's executive chef, Adam Stephens.

"We just want to make sure if our people see him (Briand) at our place that they know there is more coming. He is not a chef at The Hope Farm because we have a great chef," Robert Evans said. "He and Adam are going to be cu-

rating some really great diners to tease out things that are coming to this concept in the future."

Bentley Evans said the new concept will offer diners the same standard of service as The Hope Farm but will have its own feel.

"It is going to be an experiential-focused place just like The Hope Farm, but it will have its own identity," Bentley said. "From all of our concepts from here on out, they (guests) are going to be able to tie back and go. That is the level that I am coming to expect because this is in the group of The Hope Farm."

That's right. This isn't the only new concept coming to the brand. Bentley said there

is more on the horizon, but the focus is on getting the current concept with Briand open.

Over his 10 years as Fisher's executive chef, Briand welcomed chefs from all over the country for his popular dinner series called Southern Grace Dinners. The names varied from James Beard winner Nina Compton, Emeril Lagasse, John Besh, Frank Stitt and, just last summer, Martie Duncan, Jim Smith, Josh Quick and Chris Lilly.

"I hate the situation that created him being available," Robert Evans said. "But the fact is he is, and I am glad we are able to create this environment for him to come do what he does."

Mayor Ralph Hellmich confirmed that the city approved the project approximately two years ago but had awaited final approval from the Alabama Department of Transportation before initiating construction.

"The good news is we can start. It is a 250-day project and it is a long-awaited project," Hellmich said. "This will make the Foley Beach Express an even safer road with the safety shoulders, which is very important, to match the Baldwin Beach Express north and south of

here."

With an average daily traffic count exceeding 20,000 vehicles, according to Alabama Department of Transportation reports, the urgency for improvements to the Foley Beach Express has been highlighted by the substantial volume of commuters utilizing the Foley Beach Express.

City officials had aimed to begin highway improvement work in late 2023. The projected 250-day work schedule means construction will coincide with the summer tourist season. However, Hellmich cautioned that postponing the project could result in escalated costs.

"We thought about try-

ing to put it off until September, but if we do that then the asphalt goes up here we're gonna have to come back and ask you for more money," Hellmich told council members.

The four-lane Foley Beach Express was initially completed in 2000, spanning a total length of approximately 14.7 miles from the Intra-coastal Waterway in Orange Beach to Alabama 59.

An extension was later added north from Foley to Interstate 10. That 13.2-mile section, known as the Baldwin Beach Express, was completed in 2014.

Grant cycle open for Tri-City nonprofits

Money is available for local nonprofits that work to improve quality of life for residents in Foley, Orange Beach and Gulf Shores.

The Advisory Committee of the Tri-City Community Foundation recently opened its annual competitive grant cycle. The Foundation, which is an affiliate of The Community Foundation of South Alabama, formed in 2018 to support people and organizations with philanthropic goals in the areas of arts, community development, education, health, human services, recreation, technology and youth.

The Foundation has awarded more than \$83,000 since its inception, according to Natalie Dunn, senior communications and programs officer for the Foundation, to 29 organizations. Grant awards vary depending on the application. Last year, over \$17,000 was awarded to six organizations, including Sight Savers America, NAMI Baldwin, South Baldwin Literacy Council, Liberty Learning Foundation,

Jennifer Claire Moore Foundation and Alabama Gulf Coast Zoo Foundation.

Since its founding in 1976, The Community Foundation of South Alabama has awarded more than \$85 million.

The committee overseeing the Tri-City organization consists of 12 members: Ed Douglas, chair, Ginny Barnes, Wade Bradford, Tammy Busby, Kim Frank, Matt Grant, Bob Higgins, Michelle Hodges, Steve Jones, Christi Koehle, David Lee and Herb Malone. Together, they determine what areas to focus on within the Tri-City community.
