Regular Meeting Minutes
Baldwin County Administration, Bay Minette

The Board of Adjustment for Baldwin County Commission, District 1 met in a special session on Wednesday, December 27, 2017, at 10:00 a.m., in the Commission Conference Room of the Baldwin County Administration Building in Bay Minette. The meeting was called to order by the Chairman, Mr. Arthur Oken. Members present included Mr. Mitchell Broughton and Ms. Charmein Moser. Also present was Planning Director Vince Jackson.

Approval of Minutes

Ms. Moser made a motion to approve the minutes of the November 1, 2017 regular meeting. The motion received a second from Mr. Broughton and carried unanimously.

SE-17003, Parnell Property

Mr. Jackson presented the request for a special exception to allow for storage buildings and boat and RV storage. Staff recommended approval of the special exception.

Mr. Broughton asked about opposition to the request and fencing.

Mr. Parnell spoke in favor of the request and stated that he plans for the facility to be fenced. No one spoke in opposition to the request.

Following a short discussion, Board Member Mitchell Broughton made a motion to approve the special exception request subject to conditions set out by staff with the additional condition of fencing for security. The motion received a second from Board Member Charmein Moser and carried unanimously.
