If payment is not received by September 30, a final 10-day notice of cancellation will be sent, with cancellation effective October 10.
Interest will accrue on the unpaid balance each month thereafter.

The terms Fund and Fund's shall mean the Association of County Commissions of Alabama Liability Self-Insurance Fund, Inc.

3. COVERAGE DOCUMENT PERIOD

FROM: 7/1/2026
TO: 7/1/2027
TERM: 12 Months

4. COVERAGE TERRITORY

This Coverage Document covers COVERED PROPERTY in The United States of America and Canada.

5. COVERAGE PROVIDED

The coverage provided under this Coverage Document applies to property described on the **Schedule of Values** or covered under the terms and conditions of the AUTOMATIC COVERAGE (NEWLY ACQUIRED), ERRORS AND OMISSIONS, or MISCELLANEOUS UNNAMED PROPERTY provisions, unless otherwise provided.

6. LIMITS OF LIABILITY

The Fund's maximum Limit of Liability in a single **Occurrence** regardless of the number of COVERED PROPERTY or coverages involved will not exceed the total value reported to us in the **Schedule of Values**.

In the event of a loss hereunder, the LIMITS OF LIABILITY shall be limited to the lesser of the following:

1. The actual adjusted amount of loss, less applicable deductible(s);
2. 100% of the value listed for COVERED PROPERTY listed on any Agreed Value Endorsement, less applicable deductible(s);
3. 125% of the real and personal property values combined, inclusive of property in the open, for each reported Location on any Property Schedule, less applicable deductible(s). Location shall mean each individual line item reported on the latest Property Schedule or other statement of values on file with the Fund (except the Agreed Value Endorsement) as of the date of loss. However, this limitation shall not apply to coverages provided within the Declarations and Property Coverage Document as respects to Property and Time Element coverage extensions where values for such are not reportable including, but not limited to, Demolition, Increased Cost of Construction, Debris Removal, Accounts Receivable, Valuable Papers and Records, Decontamination Costs, Extra Expense, et al., and as further described within the Coverage Document; or
4. The Limit of Liability shown in these Declarations or endorsed or scheduled onto this Coverage after inception.

The terms and conditions in this Document, including the Sublimits below, constitute the program as a whole for the Named Member. The Sublimits stated below are a part of, and do not increase, any LIMITS OF LIABILITY of the program.

The following Sublimits apply on a per **Occurrence** basis unless otherwise stated.

Each sublimit stated in these Declarations applies as part of, and not in addition to, the overall limit for an occurrence covered hereunder. Each sublimit is the maximum amount potentially recoverable for all covered loss, damage, expense, time element or other insured interest arising from or relating to that aspect of the occurrence, including but not limited to type of property, construction, geographic area, zone, location, or peril.

If covered under the Coverage Document, any sublimit for **Earthquake, Flood, or Named Storm** is the maximum amount potentially recoverable for all covered loss, damage, expense, time element or other insured interest arising from or relating to such an occurrence. All other Sublimits are a part of, and do not increase the **Earthquake, Flood, or Named Storm** Sublimit.

Further, if **Flood** occurs in conjunction with a **Named Storm** or **Earthquake**, the **Flood** sublimit applies within and erodes the sublimit for that windstorm, named storm, named windstorm, earthquake, or earth movement.

When a Sublimit is shown as applying as an annual aggregate, the Fund's maximum limit of liability will not exceed such limit during any COVERAGE DOCUMENT PERIOD regardless of the number of COVERED PROPERTY and coverages involved.

Time Limits

In addition to the time limits shown in the Coverage Document, the following apply:

30 Day Period: INTERRUPTION BY CIVIL AUTHORITY

30 Day Period: INGRESS/EGRESS

180 Day Period: EXTENDED PERIOD OF INDEMNITY

7. CONTRIBUTION

This Coverage Document is issued in consideration of an annual contribution of \$2,539,356.76.

8. WAITING PERIOD

For the purposes of applying SERVICE INTERRUPTION, INTERRUPTION BY CIVIL AUTHORITY and INGRESS/EGRESS Coverage, the **Waiting Period** is twenty-four (24) hours.

9. DEDUCTIBLES

In each case of loss covered by this Coverage Document, the Fund will be liable only if the Named Member sustains a loss in a single **Occurrence** greater than the underlying limit or the applicable deductible specified below, and only for its share of that greater amount.

A. Named Storm

Property consisting of **Vehicles** and **Mobile Equipment** shall not be subject to the deductible for **Named Storm** in **Tier One Counties**.

For COVERED PROPERTY wholly or partially situated in **Tier One Counties**, the deductible shall be 2% of the total actual value of all COVERED PROPERTY per **Occurrence** irrespective of the number of locations. If the claim as respects Losses from a **Named Storm** involves loss or damage at more than one COVERED PROPERTY, the deductible amount shall be calculated separately for each COVERED PROPERTY suffering loss or damage and applied separately to the adjusted loss at each COVERED PROPERTY, but in no event, shall the total deductible to be applied to a single **Occurrence** with respect to such losses be less than the minimum amount of \$100,000, for all such loss or damage at all COVERED PROPERTY, and coverages, combined.

As respects **Named Storm** losses in all other counties, a \$50,000 deductible per **Occurrence** for all COVERED PROPERTY and coverages, combined, shall apply.

As respects buildings or structures wholly or partially situated in a **Special Flood Hazard Area**, the following deductibles shall apply separately for loss from the perils of **Flood** or **Storm Surge** resulting from a **Named Storm**:

- 1) for all coverages covered against under this Coverage Document, if the Named Member purchases coverage from the National Flood Insurance Program, the deductible shall be the greater of the amount of recoverable from the National Flood Insurance Program or the **Actual Cash Value**, not to exceed \$500,000. This deductible shall apply for each building or each structure for real property, and contents at each building or each structure.
- 2) for all coverages covered against under this Coverage Document, if the Named Member does not purchase coverage from the National Flood Insurance Program, or the property is not eligible for coverage from the National Flood Insurance Program, or in the event the National Flood Insurance Program lapses or is discontinued, the deductible shall be \$500,000 at each building or each structure for real property, \$500,000 for contents at each building or each structure, and \$500,000 each for any other COVERED PROPERTY.
- 3) If the community is participating in the Emergency Program under the National Flood Insurance Program, \$500,000 as noted within this Section A. (1) is replaced with \$100,000. If the property is eligible for coverage in the Emergency Program, \$500,000 as noted within Section A. (2) is replaced with \$100,000.

However, these deductibles shall not apply to COVERED PROPERTY located outside of an area designated as a **Special Flood Hazard Area** nor to ensuing physical loss, or damage or destruction not otherwise excluded herein. Further, the deductibles described under paragraphs (1), (2), and (3) above shall apply individually and supersede the "two or more deductible provision" under the Deductible Conditions of the Declarations.

B. Flood

Property consisting of **Vehicles** and **Mobile Equipment** shall not be subject to the **Special Flood Hazard Area** deductible detailed below.

As respects buildings or structures wholly or partially situated in a **Special Flood Hazard Area**, the following deductibles shall apply separately for loss from the peril of **Flood**, as covered and defined under the National Flood Insurance Program:

- 1) for all coverages covered against under this Coverage Document, if the Named Member purchases coverage from the National Flood Insurance Program, the deductible shall be the greater of the amount recoverable from the National Flood Insurance Program or the **Actual Cash Value**, not to exceed \$500,000. This deductible shall apply for each building or each structure for real property, and for contents at each building or each structure.
- 2) for all coverages covered against under this Coverage Document, if the Named Member does not purchase coverage from the National Flood Insurance Program, or the property is not eligible for coverage from the National Flood Insurance Program, or in the event the National Flood Insurance Program lapses or is discontinued, the deductible shall be \$500,000 at each building or each structure for real property, \$500,000 for contents at each building or each structure, and \$500,000 each for any other COVERED PROPERTY.
- 3) If the community is participating in the Emergency Program under the National Flood Insurance Program, \$500,000 as noted within this Section B. (1) is replaced with \$100,000. If the property is eligible for coverage in the Emergency Program, \$500,000 as noted within Section B. (2) is replaced with \$100,000.

However, these deductibles shall not apply to COVERED PROPERTY located outside of an area designated as a **Special Flood Hazard Area** nor to ensuing physical loss, or damage or destruction not otherwise excluded herein. Further, the deductibles described under paragraphs (1), (2), and (3) above shall apply individually and supersede the "two or more deductible provision" under the Deductible Conditions of the Declarations.

For all other Flood losses, the deductible shall be \$50,000.

The deductibles described under paragraphs (1), (2), and (3) above shall apply individually and supersede the "Two or More Deductibles" provision under the Deductible Conditions.

C. Earthquakes

For all losses due to Earthquakes, the deductible shall be \$50,000.

D. Hail

As respects the peril of hail not associated with or occurring in conjunction with a **Named Storm**, the deductible shall be 1% of the total actual value of all COVERED PROPERTY per **Occurrence** irrespective of the number of locations. If a claim as respects Losses from hail involves loss or damage at more than one COVERED PROPERTY, the deductible amount shall be calculated separately for each COVERED PROPERTY suffering loss or damage and applied separately to the adjusted loss at each COVERED PROPERTY, but in no event shall the total deductible applied to a single **Occurrence** with respect to such losses be less than the minimum amount of \$10,000, for all such loss or damage at all COVERED PROPERTY, and coverages, combined.

The deductibles described under this section D shall apply individually and supersede the "Two or More Deductibles" provision under the Deductible Conditions.

E. All Other Perils

As respects losses from any other peril, the following deductibles per **Occurrence** for all COVERED PROPERTY and coverages combined shall apply unless a different deductible is stated on any **Schedule of Values**:

1. To Any Vehicle	<u>\$5,000/\$40,000</u>
2. To Any Mobile Equipment	<u>\$10,000</u>
3. To Any Watercraft	<u>N/A</u>
4. To Any Fine Arts item	<u>\$1,000</u>
5. To Any Other Covered Loss	<u>\$1,000/\$5,000/\$10,000</u>

F. Deductible Conditions

(1) Two or More Deductibles

In the event of any **Occurrence** resulting in loss or damage covered against under this Coverage Document for which two or more deductibles apply, the total deductible shall not exceed the single largest deductible applicable to the **Occurrence**.

However, in any **Occurrence** where loss or damage is caused by more than one peril covered against under this Coverage Document, the Named Member shall have the right to separate the loss amount by peril for the purposes of application of the deductible(s) specified in this section, notwithstanding the above reference to two or more deductibles.

(2) Percentage Deductibles

For any deductible expressed as a percentage of actual value at the time when such loss occurs, the percentage deductible shall apply against those values reported in the latest **Schedule of Values** on file with the Fund for the COVERED PROPERTY which is affected and being reported for loss.

If the property affected and being reported for loss is not so reported in the **Schedule of Values** on file with the Fund, but otherwise covered, the percentage deductible shall apply against the total cost, per the VALUATION clause of the LOSS ADJUSTMENT AND SETTLEMENT section of the Coverage Document, as of the date of the loss at the COVERED PROPERTY where physical damage occurred and for which the Named Member is making a claim for loss.

The Fund agrees with the Member in consideration of the payment of the premium-contribution and in reliance upon the statements in the application and subject to the Limits of Coverage, exclusions, conditions, and other terms of this Endorsement as follows:

1. Coverage Agreement

This Endorsement for Canine Coverage amends the Property Coverage Document, Section A – Property Coverage, 2. Property Excluded, C., with respect to animals, to cover the scheduled dog(s) against death which results, directly or indirectly, from accident in the line of duty up to the applicable sublimit. Scheduled dog(s) are also covered against theft and death resulting directly from theft on the following conditions:

- A.** If the dog has a tattoo number or microchip that is registered with a recognized registry and is stated on the application for this coverage.
- B.** If for at least twelve (12) months prior to this coverage, no threats were made against the Member or the dog and no attempted thefts were made against the dog.
- C.** If a theft occurs, the Fund's liability begins 90 days from the date the Fund is advised of theft and the dog is not recovered during that time.
- D.** The theft of the dog is reported at once to the appropriate law enforcement agency. The Member must not pay or promise to pay a ransom or give any third party assurance of intent to pay.
- E.** The Fund will not pay more than 90% of the scheduled amount.

The Fund also agrees to reimburse the Named Member for reasonable and customary fees for surgical procedures performed on a covered dog and for reasonable and customary after-care while the dog is kept on premises where the surgery is performed. The after-care coverage is limited to 50% of the cost of surgery and no more than fourteen (14) days from the time of surgery. The limit of coverage for covered surgery and after-care per dog per Coverage Period is \$2,500.

2. Exclusions

Canine Coverage does not cover any loss resulting directly or indirectly from:

- A.** Use of any dog in pari-mutuel racing; or any gaming activity;
- B.** Surgical operations unless required in an attempt to prevent death or humane destruction and performed by licensed veterinarian;
- C.** Administration of drugs, medication or inoculation, unless:

 - (2) Administered by or at the direction of a licensed veterinarian;

- J. With respect to surgical operations, the Fund will not cover;
 - (1) Any surgery not performed by a licensed veterinarian;
 - (2) Conditions existing, diagnosed or treated prior to the effective date of this endorsement;
 - (3) Operations not performed under general anesthesia;
 - (4) Any elective or voluntary surgical procedure; or
 - (5) Postmortem surgical operations.

3. Loss Adjustment and Settlement

- A. The Fund will not pay for any claim on a dog that suffered from illness and/or injury prior to the inception of this coverage and NOT disclosed on the application while owned by the Named Member and/or incurred in the past twelve (12) months.
- B. If the dog dies, the Member must have the postmortem examination done at the Member's expense, by a licensed veterinarian and provide this to the Fund within sixty (60) days.
- C. Coverage will cease on any dog in which the Member has, temporarily or permanently, given up all or part of ownership rights by sale, by lease or for any reason.
