Foley woman charged with felony after domestic stabbing incident

A domestic dispute turned violent late Wednesday night, resulting in a stabbing on the 21000 block of U.S. Highway 98 in

Foley.
The incident, which occurred around 11 p.m. on June 19, has led to serious charges for a Foley woman.

Shau Yanite Pickens, 43, was arrested after allegedly stabbing her boyfriend in the abdomen during an argument. The Foley Police Department responded to

the scene, discovering that the long-time dating partners had been involved in a heated altercation that escalated into physical violence.

Pickens' boyfriend was ini-tially rushed to South Baldwin Regional Medical Center and later airlifted to Ascen-sion Sacred Heart Hospital in Pensacola, He is being treated for a non-life-threatening stab

wound and is expected to recover Following a thorough on-site investigation, police gathered evi-dence and information leading to Pickens' arrest. She has been charged with domestic violence in the 2nd degree, a felony, and is cur rently held at Foley City Jail, awaiting transport to Baldwin

self-defense claims.

"We are dedicated to interrupting the cycle of violence commonly associated with domestic violence and will continue to work toward that end in this case." the department said in a news release

Further details will not be released until the investigation concludes.

The collection of limbs, yard waste, and on Monday, July 8. Crews will start with routes regularly sched-uled for that day and ie in areas where yard waste was original-ly scheduled for collection on Wednesday, July

Garbage collection will be prioritized, followed by recyclables, until all ollections are complet ed and up to date. Yard waste routes may experience delays for several days until all pickups are finalized. All collection routes

will begin at 6 a.m. each day. Residents are en-couraged to set out their items early to ensure timely pickup.
