WELCOME, INVOCATION AND PLEDGE OF ALLEGIANCE

Commissioner Ball called the meeting to order at 8:31 a.m. Following the Invocation by Commissioner Underwood, and the Pledge of Allegiance led by Commissioner Gruber, the Commission transacted the

District Attorney's Office

Robert Wilters, District Attorney, discussed the FY 2025 budget request for the District Attorney's Office which has no increase in funding from FY 2024. Mr. Wilters said the DA's Office is requesting the Commission to help maintain the status quo for the upcoming fiscal year.

Coroner's Office

Dr. Brian Pierce, Coroner, discussed the FY 2025 budget requests for the Coroner's Office. The Commissioners and Dr. Pierce discussed Dr. Pierce's request for a salary increase and the legislative process involved if the Coroner's salary was to be raised.

Baldwin County Economic Development Alliance (BCEDA)

Lee Lawson, President and CEO, discussed the highlights of the partnership between the EDA and the Commission, including Novelis and the number of new jobs in Baldwin County.

Discussion took place regarding the allocation to BCEDA for FY 2025.

Miscellaneous Appropriations

The Commissioners and Ms. Hodges discussed the miscellaneous budget requests received by the Budget Department for FY 2025, reducing or eliminating funding for the Gateway Initiative and Rafael's Legacy, reducing the appropriation to the Baldwin Pops to \$1,000, and the North Baldwin Animal Shelter to \$10,000. The Commissioners discussed reducing expenses where possible and not adding new miscellaneous appropriations at this time in order to help balance the budget.

Further discussion took place regarding changing appropriations to the Chambers of Commerce to dues where the County Commission would be a member of each Chamber of Commerce instead of donating money to the Chambers, and new positions for the Probate Office due to the upcoming retirement of the Chief Clerk of Probate.

Archives Department, Events at Bicentennial Park

The Commissioners, Ms. Hodges, and Ms. Anderson discussed FY 2025 capital requests for Bicentennial Park including lawn care maintenance and dedicated lawn care equipment for use at the park, recognizing Veterans from different conflicts, the First Settlers Brick Paving Project, strategic goals being better refined for Bicentennial Park, Archives projects and events, the Strategic Plan for the park, labor costs for the Christmas Extravaganza event and scaling back the event to cut costs, overtime costs for Parks Department employees for events, finding volunteers to work the Christmas event, eliminating overtime for events preparation, and covering the costs for each event to be held.

Parks Department

The Commissioners, Mr. Lundy, and Mr. Steele discussed the addition of new parks, equipment and personnel needed to maintain the parks.

Personnel Department

Ms. Hanak discussed personnel requests for various departments, growth plans for departments, and restructuring certain departments to allow for growth.

The Commissioners and Ms. Hanak discussed the Building Maintenance Department's request for a 5% increase in pay for all staff, and the Revenue Commission Reappraisal Department's request for pay scale adjustments.

The Commissioners discussed annual COLA increases and being fair across the board with any pay increases.
