EXTENSION AND AMENDMENT OF THE CONTRACT FOR PROFESSIONAL SERVICES

1. Purpose; Scope

Each of Via Mobility, LLC, a Delaware company with its principal office located at 114 5th Ave, Floor 16 and 17, New York, New York 10011 (“**Via**”), and Baldwin County Commission (“**Customer**”), hereinafter the “**Parties**,” entered into an agreement titled Contract for Professional Services and into a service order titled Baldwin County Deployment Service Order, each dated June 18, 2020, and modified by the Extension and Amendment Agreement, dated September 21, 2021, and modified by the Extension and Amendment Agreement, dated September 20, 2022 (together, the “**Agreement**”). By this Extension and Amendment Agreement (“**Extension**”) the parties agree towards continued collaboration of operation of the services provided under the Agreement.

Amendment

2. Duration

This Extension shall extend the period of performance of the Agreement by a period of twelve months, from October 1, 2023 until September 30, 2024 (inclusive). The Effective Date of this Extension shall be October 1, 2023.

3. Conflict of Terms.

Unless otherwise stated, all terms and conditions contained in the Original Order are also applicable to this Extension. If a term contained in this Extension is in conflict with the terms of the Original Order, the specific term in this Extension shall take precedence. Any term or condition in the Original Order, including all Appendices not affected by this Extension, shall remain in full force and effect.
