The first is by obtaining three quotes, the highest of which will establish fair market value; a second is by advertising in a newspaper of local circulation or other medium requesting bids; a third is by public auction. A copy of the Vehicle Quote/Bid Sheet is enclosed for your use. Reference the enclosed "Transit Vehicle Disposition Replacement Policy" and the sample calculations form for guidance in handling the remaining balance of funds.

The titles for the vehicles listed above are enclosed. The liens are released for the purpose of disposition.

Also, please include a copy of the back portion of each title that shows the "Assignment of Title by Registered Owner." This will serve as ALDOT's assurance that this equipment has been removed from public transportation service.

Please ensure that all transit markings are removed prior to the completion of this activity.
