The following individuals were present in favor of the rezoning request:

Mr. Jeff Windham, President of Hamm Enterprises Ltd., provided a handout to the Commissioners which included letters from the Department of the Army, Corps of Engineers regarding jurisdictional wetlands and maps of the property. Mr. Windham discussed the history of the Spanish Cove development.

Mr. David Shumer with Barton & Shumer Engineering, noted the subject property was approved and recorded as a plat to be developed prior to districting and zoning.

There being no further requests to address the Commission, Chairman Underwood closed the public hearing at 11:45 a.m.

Discussion took place regarding legal options regarding rezoning, the factors the Commission considers for rezoning requests, and the requirements of the Subdivision Regulations being evaluated with any future subdivision development.

Motion by Commissioner Matthew P. McKenzie, seconded by Commissioner Charles F. Gruber, to deny the request to rezone Case No. Z24-10 Hamm Enterprises LTD Property, as it pertains to the rezoning of 22.87 acres, more or less, as located in Planning (Zoning) District 33, from RA, Rural Agricultural District, to RSF-4, Residential Single-Family District.
