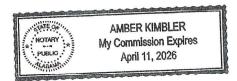

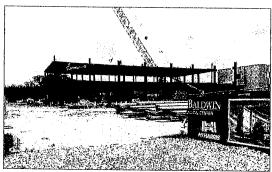

FROOT PROMISES.

Construction continues at South Baldwin Regional Medical Center. The city of Foley is studying a plan to create a medical overlay district in the area near the hospital.

Foley studying medical overlay district

FOLEY A medical overlay district could encourage the expansion of medical ser vices to meet the needs of a growing population while protecting surrounding prighborhoods

Foley officials are studying the creation of an overlay district in the area of South Baldwin Regional Medical Center in the northern area of the city.

The hospital is currently undergoing a \$200 million ex-pansion that will increase the facility's capacity to 142 beds Wayne Dyess, executive direc-tor of planning and infra-structure, said the expansion is a good time to look at encouraging the development of medical facilities in the area.

We were looking for ways to encourage a conglomeration of medical uses near the hospital, to get the synergies

between the new hospital and potential growth and the need for medical care," Dyess said. "This is a way that we are looking to try to incentiv-ize this."

Dyess said the process is still in the planning stages. He said city officials have met with developers and members of the Baldwin County Economic Develop-ment Alliance to discuss the

"We're working with the EDA, looking for ways to in-centivize additional and more diverse health care resources here as we've got a growing population," Dyess said. "Even things like assisted living, those kinds of things, would be appropriate as well."

He said the creation of the

district would not change any existing zoning in the city. "Our vision for the medical

overlay district is predominantly uses such as hospital support, clinics, therapy fa-cilities and other directly re-lated health care facilities; but to also include ancillary medical uses such as residen tial care facilities, and assisted living facilities," Dyess said. "One could also find other auxiliary uses such as food, coffee shops, temporary style occupancy for health care employment such as traveling nurses. In the medi-cal overlay concept the hospi-tal essentially acts as the "anchor" similar to big box retail

The bosnifal, which opened at the site in 1958, is located near residential areas. Dyess said a medical overlay district could offer a buffer to the expansion of medical offices into neigh-

serving as the economic en-gine for surrounding smaller

businesses.

Foley developing strategic plan

FOLEY Foley planners vill be meeting with residents and officials in upcoming months to develop a strategic plan to guide municipal growth.

Foley City Council voted to hire the company Berry-Dun of Portland, Maine to help develop the plan. Wayne Dyess, executive di-rector of infrastructure and development, said the project will help officials make plans on issues such as finances to deal with continuing growth.

"This is not a land use plan," Dyess said. "This is more a business strategic plan on priorities, goals and where we're going in the future. It's a great project and we're very excited

Dyess said the city will schedule public meetings and other discussions with small groups and Foley of-

ficials to go over the plan.
"It helps define what our objectives and goals are for the city and puts bench-marks in place to make sure we're on track to achieve those goals," Dyess

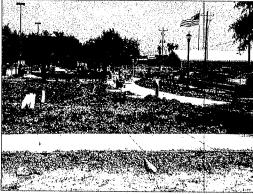
Mayor Ralph Hellmich said the city has developed commrchensive plans in the past. The new plan will also show banks and bond companies how Foley is making financial preparations for the future.
""In the financial world

in order to keep achieving the standards that we have it was encouraged by the fi nancing organization that e have a strategic plan." Hellmich said.

Dyess said the city will also use the plan in prepar ing future budgets.

"It's also a great tool when you include in the budgeting aspect of this to make sure that when you have these priorities and goals and their prioritiza tion and those kinds of things that you're beloing fund those too so helps kind of focus the direction but also focus the funding and the budgeting to achieve those goals," Dyess said. The plan process will

begin with BerryDunn con ducting research and devel-oping a work plan and schedule for the project. As work continues, meetings will be scheduled and a draft plan propared using information gathered in the process before a final plan
