BLACKMON, III**

WHEREAS, we the members of the Baldwin County Commission, want the family to know that we mourn the death of Mr. Bert Daniel “Danny” Blackmon, III of Bay Minette, Alabama, on Wednesday, November 11, 2020; and

WHEREAS, Bert Daniel “Danny” Blackmon was born on November 7, 1948, in Florala, Alabama, was a resident of Bay Minette, Alabama and a retired teacher and historian at Summerdale and Foley Middle Schools; and

WHEREAS, Mr. Blackmon was a retired Veteran of the U.S. National Guard and loved history and enjoyed re-enacting many eras. He was a member of the General Galvez Sons of the American Revolution as well as a member of the Society War of 1812 State of Alabama where he was the historian for approximately 10 years; and

WHEREAS, Mr. Blackmon was an active member of the Fort Blakeley Camp #1864, Sons of the Confederate Veterans and the Brig. General St. John Richardson Liddell Chapter #271, Military Order of the Stars and Bars and Mr. Blackmon held a special love for the War of 1812 and a very special connection to Fort Mims. Mr. Blackmon assisted with field trips to the site as well as to Bicentennial Park in Stockton; and

WHEREAS, Mr. Blackmon was an active member of the Baldwin County Historic Development Commission and in observance of Confederate History month in April of each year, he made a presentation to the Baldwin County Commission. He served on the Alabama 200 Baldwin County Bicentennial Steering Committee for three consecutive years from January 2017 until December 2019; and

WHEREAS, Mr. Blackmon worked as a part-time Landscape Technician I and front gate attendant at the Baldwin County Bicentennial Park in Stockton, Alabama, where he devoted all his time to his public duties, until his illness; and


WHEREAS, throughout his life, Mr. Blackmon demonstrated his dedication and love for Baldwin County by his selfless public service through history to the citizens and the community; and


Blackmon and extend our heartfelt sympathy to his family and friends, whose grief is shared by many.
