WHEREAS, Baldwin County Planning and Zoning Department has petitioned the Baldwin County Commission, on behalf of Jay Broughton, P.E. to rezone certain property, in Planning (Zoning) District No. 39, for property identified herein and described as follows:

COMMENCING AT A POINT THAT IS THE SOUTHWEST CORNER OF SECTION 2, TOWNSHIP 7 SOUTH, RANGE 2 EAST, BALDWIN COUNTY ALABAMA; THENSE RUN S89º45'09"E, A DISTANCE OF 40.00 FEET TO A POINT LOCATED ON THE EAST RIGHT OF WAY LINE OF STATE HIGHWAY 181 BEING THE POINT OF BEGINNING OF THE PROPERTY HEREIN DESCRIBED; THENCE RUN ALONG SAID EAST RIGHT OF WAY LINE N00º20'18"E, A DISTANCE OF 1034.59 FEET TO A POINT; THENCE RUN S89º37'21"E, A DISTANCE OF 700.00 FEET TO A POINT; THENCE RUN N00º17'34"E, A DISTANCE OF 296.72 FEET TO A POINT; THENCE RUN S89º46'22"E, A DISTANCE OF 587.56 FEET TO A POINT; THENCE RUN S00º13'14"W, A DISTANCE OF 1329.93 FEET TO A POINT; THENCE RUN N89º45'09"W, A DISTANCE OF 1290.06 FEET TO THE POINT OF BEGINNING. CONTAINING 34.59 ACRES, MORE OR LESS.
