Good afternoon, ladies.

I am requesting an updated approval letter for the above referenced applicant based on an oversight issue: the above referenced applicant, dba Bon Secour C Store, submitted a transfer application to ABC on June 25, 2024. The applicant provided a good lease, but there was a discrepancy between the lease address and the address of the current ABC licensee. The address in the applicant's lease was 18019 County Road 10, Foley, but the

address in the Current ABC licensee was 18019 County Road 10, Unit A, Foley. Very unfortunately, this discrepancy was overlooked and subsequently the applicant was provided an application which he fully executed and proceeded with his due diligence. On August 6, 2024, the county issued their approval letter for Bon Secour C Store's transfer application.

The discrepancy between the two addresses (one lease **without** the unit designation and an existing license **with** the unit designation) was not realized until the application was reviewed by Central Office on August 8<sup>th</sup>. At that time, Central Office requested that the applicant update his lease to include the Unit designation for the sake of consistency; applicant complied and provided an updated and fully executed lease on August 14, 2024. The rest of his supporting documentation was provided within a few days of our receipt of his updated lease.

In summary: what changed from Bon Secour C Store's first application to his second application was the addition of a Unit designation. I've attached his updated ABC application that's been corrected for the Unit designation.
