Such consent and approval has no impact on, and does not affect in any manner whatsoever, the borrowing capacity of Baldwin County, Alabama and shall never be taken to impose any liability of any kind whatsoever upon the undersigned as the individual members of the Baldwin County Commission or Baldwin County, Alabama.

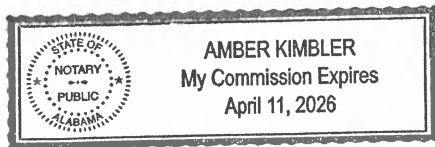

LEGAL NOTICE OF PUBLIC HEARING Regarding St. Michael Catholic High School

The Educational Building Authority of the City of Fairhope, Alabama-St. Michael Catholic High School (the "Authority"), a public corporation incorporated and organized pursuant to Chapter 17 of Title 16 of the Code of Alabama 1975 (the "Authorizing Act"), hereby provides public notice that representatives of the Authority will conduct a public hearing in Fairhope City Hall at 161 North Section Street in the City of Fairhope, Alabama, Alabama (the "City"), at 3:00 p. m. on Monday, November 14, 2022, with respect to (i) the proposed issuance by the Authority pursuant to the Authorizing Act of a Revenue Bond, Series 2022 (the "Revenue Bond") in the maximum stated principal amount of \$2,600,000 and (ii) the advance of the principal of the Revenue Bond to St. Michael Catholic High School, an Alabama nonprofit corporation (the "School"), for use by the School to refinance the indebtedness heretofore incurred by the Authority, pursuant to the Authorizing Act, for the benefit of the School to pay the costs of the educational facilities, library, technology center, dining halls, media center, recreational facilities, multi-purpose building, and parking facilities which constitute St. Michael Catholic High School located at 11732 Higbee Road within the jurisdiction of the Authority (the "Project"). The School shall, for the account of the Authority, make payments at such times and in such amounts as shall provide for the payment of the principal of and interest on the Revenue Bond in full when due. The issuance of the Revenue Bond will not constitute or create a pecuniary obligation (whether direct, indirect, or contingent), or charge against the assets, credit, or funds of, the City of Fairhope, Alabama, Baldwin County, Alabama, the State of Alabama, or any other political subdivision or taxing authority of the State of Alabama. The public hearing will provide an opportunity for all interested persons to express their views, both orally and in writing, on the proposed issue of the Revenue Bond and with respect to the Project.
