Terri Graham, CEO of the Baldwin County Solid Waste Disposal Authority, provided background information regarding the process for development of the Baldwin County Comprehensive Solid Waste Management Plan 2025-2035 and noted all 14 municipalities in Baldwin County have opted in to the plan.

Mr. Phil Davis with LaBella Associates provided a presentation regarding the Comprehensive Solid Waste Management Plan and noted adoption of the final plan would be forthcoming to the January 21, 2025, Commission meeting.

Chairman McKenzie opened the public hearing at 10:51 a.m. and asked if there is anyone present who wishes to speak.

There being no requests to address the Commission, Chairman McKenzie closed the public hearing at 10:52 a.m.

ES PLANNING AND ZONING

ES1 <u>Amendments to the Baldwin County Subdivision Regulations</u>

Jay Dickson, Planning Director, provided a summary of the amendment process, requirements, and highlights of the proposed changes and updates to the Baldwin County Subdivision Regulations. Mr. Dickson noted the comments received during the public comment period have been incorporated into the Subdivision Regulations, updates have been made to stormwater management and open space requirements, and text has been cleaned up for clarification.

Chairman McKenzie opened the public hearing at 10:58 a.m. and asked if there is anyone present who wishes to speak.

The following individuals were present with comments, questions or concerns regarding the proposed amendments to the subdivision regulations:

Ms. Judy Smith Mr. Michael Taylor Mr. Luke Kiszla Mr. Vince Emmons Ms. Maria Marks Mr. Gerry McManus Ms. Christine Saia Ms. Susan Bracken

Ms. Smith discussed concerns regarding the requirement of a 60-foot right-of-way for smaller lots, the costs of the proposed amendments to developers and future costs to the Commission for maintenance.

Mr. Taylor, representing the Baldwin County Road Builders, suggested the Commission get help to determine costs.

Mr. Kiszla, Government Affairs Director with Mobile Baykeeper, expressed his support of the proposed amendments to the subdivision regulations due to verification that utilities can provide an adequate level of service, detailed plans for stormwater and low impact development, minimal environmental disruption, and increased wetland buffers.

Mr. Emmons with Berkshire Hathaway Cooper Real Estate, asked how the amendments affect sales of property in progress and if the amendments pass, and when they will go into effect.

Ms. Marks asked how the proposed amendments would affect current home owners' association fees.

Mr. McManus discussed the preliminary plat process and sewer service.

Ms. Saia discussed concerns regarding the increased strain to infrastructure and services, roadways, overcrowded schools, and environmental damage.

Ms. Bracken discussed placement of signage notifying the public of proposed developments and the importance of communication among local planning commissions.

There being no further requests to address the Commission, Chairman McKenzie closed the public hearing at 11:20 a.m.

Mr. Dickson addressed concerns regarding the 60-foot right-of-way requirement, mobile home parks being done through a Planned Unit Development process, state law requirements regarding notification of adjacent property owners and placement of signage notifying the public of proposed developments, coordination with municipalities regarding access to developments, sewer requirements including expansion and conditional improvements as necessary to service the development, and the proposed amendments being for future development, not retroactive.

Discussion took place regarding the Eastern Shore Metropolitan Planning Organization providing regular updates to the Commission regarding new developments, the proposed amendments being for future development and not retroactive, the idea of creating one common set of subdivision requirements across municipalities, the increased cost of housing, and the role of the County Commission regarding subdivision regulations.

Mr. Dickson explained the subdivision regulations are the technical standards for developments in order to maintain the quality of life for the residents of Baldwin County, but have no impact to the market costs of housing.

Motion by Commissioner Billie Jo Underwood, seconded by Commissioner James E. Ball, to adopt Resolution #2025-001 which:

1) Amends the Baldwin County Subdivision Regulations with the amendments as set forth in Exhibit "A" attached thereto; and

2) Provides that said amended Baldwin County Subdivision Regulations, as set forth in Exhibit "A" attached thereto, shall become effective January 7, 2025; and

3) Provides that the Chairman of the Baldwin County Commission is hereby authorized to certify, on behalf of the Baldwin County Commission, to the Judge of Probate, of Baldwin County, Alabama, said amended Baldwin County Subdivision Regulations.
