DETERMINATION OF THE BALDWIN COUNTY COMMISSION, REGARDING **CASE No. Z25-16, SR Development LLC Property** SUCH DETERMINATION AS AUTHORIZED PURSUANT TO SECTION 45-2-261 THROUGH SECTION 45-2-261.18, <u>CODE OF ALABAMA</u> (1975).

WHEREAS, Baldwin County Planning and Zoning Department has petitioned the Baldwin County Commission, on behalf of SR Development LLC to rezone certain property, in Planning (Zoning) District No. 22, for property identified herein and described as follows:

Beginning at the Northwest Corner of Lot 9, Daszczuk Estates as Recorded of Slide 2811-E, Probate Court Records, Baldwin County, Alabama, Thence South 00 degrees 06'37" East 469.78 Feet; Thence North 89 degrees 57'29" West 236.06 Feet; Thence North 00 degrees 06'37" West 469.95 Feet to a point on the South Line of County Road 32; Thence South 89 degrees 54'59" East Along Said South Line 236.06 Feet to the Point of Beginning, containing 2.55 acres, more or less.

Otherwise known as tax parcel number, **05-53-02-04-0-000-003.001** as found in the office of the Revenue Commissioner of Baldwin County, Alabama; and

WHEREAS, the petitioner has requested that 2.55+/- acres be rezoned from RA, Rural Agricultural District, to B-2, Neighborhood Business District; and

WHEREAS, the Baldwin County Planning and Zoning Commission held a public hearing on May 1, 2025 and voted to recommend Approval of the rezoning request; and

WHEREAS, the Baldwin County Commission held a public hearing on June 24, 2025; and

WHEREAS, the requirements of SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975), regarding procedures to consider this rezoning request, which would affect the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 22 Official Map, have been met; now therefore

BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED, that the petitioner's request to rezone 2.55+/- acres (Case No. Z25-16, SR Development Property) as herein identified and described and as found within the confines of Planning (Zoning) District No. 22 from RA, Rural Agricultural District, to B-2, Neighborhood Business District, which amends the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 22 Official Map, is hereby APPROVED.
