
SCOPE OF WORK

From existing UF HH, using (2) 1.25" HDPE, bore 100' to customer building. Open cut/repair concrete. Rise up 5' using 1.25" PVC to mount NEMA. From NEMA, rise up another 7' to above the drop ceiling. Install a wall mount LGX at customer demarc. From customer demarc, pull a 150' 12ct MPO out to UF NEMA. From NEMA, pull a 300' 24ct out to UF HH in ROW. Leave 30' slack at demarc, 50' slack inside NEMA and remaining slack inside UF HH. Construction process to take 2-3 days. Property grounds will be restored. UF will notify property at least 24 hours prior to construction. Tracer wire must be placed when cable is pulled, if not UF will request reason why wire is not placed at time of installation.



