WHEREAS, the Baldwin County Commission will maintain these vehicles in accordance and compliance with FTA requirements; and

WHEREAS, the Baldwin County Commission will include these transferred vehicles on its equipment inventory records.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION AS FOLLOWS:

- 1) The above stated recitals are true and correct and incorporated by reference herein.
- 2) The Baldwin County Commission hereby authorizes the acceptance of the transit vehicles, as identified in Exhibit A, from the Escambia County Board of Commissioners and assume the FTA interest in the amount of \$415,271.
- 3) The Baldwin County Commission hereby authorizes the Chairman to sign this Resolution.
- 4) This Resolution shall take effect immediately upon adoption by the Baldwin County Commission.
