DETERMINATION OF THE BALDWIN COUNTY COMMISSION, REGARDING **CASE No. Z25-37, Corcoran Property** SUCH DETERMINATION AS AUTHORIZED PURSUANT TO SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975).

**WHEREAS**, Baldwin County Planning and Zoning Department has petitioned the Baldwin County Commission, on behalf of Daphne VIP Storage, LLC – Frank McGinley to rezone certain property, in Planning (Zoning) District No. 15, for property identified herein and described as follows:

Otherwise known as tax parcel numbers, **05-43-06-24-0-000-002.000** and **05-43-06-24-0-000-002.002** as found in the office of the Revenue Commissioner of Baldwin County, Alabama; and


**WHEREAS**, the petitioner has requested that 13.5+/- acres be rezoned from RSF-E, Residential Single Family Estate District, to RA, Rural Agricultural District; and

**WHEREAS**, the Baldwin County Commission held a public hearing on August 19, 2025; and

**WHEREAS**, the requirements of SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975), regarding procedures to consider this rezoning request, which would affect the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 15 Official Map, have been met; now therefore

**BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED**, that the petitioner's request to rezone 13.5+/- acres (Case No. Z25-37, Corcoran Property) as herein identified and described and as found within the confines of Planning (Zoning) District No. 15 from RSF-E, Residential Single Family Estate District, to RA, Rural Agricultural District, which amends the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 15 Official Map, is hereby **APPROVED**.
