WHEREAS, the petitioner has requested that 2.98 +/- acres be rezoned from RSF-E, Residential Single Family Estate District, to RSF-1 Residential Single Family District and

WHEREAS, the Baldwin County Commission held a public hearing on May 21, 2024; and
