



Foley voters to return to Civic Center for 2025 municipal elections

Foley voters will cast their ballots at the Civic Center for the 2025 munici-pal elections, returning to the location used before the COVID-19 pandemic temporarily shifted polling to a larger venue. Foley City Council ap-

proved the first reading of an ordinance on Monday, March 17, to designate the Civic Center as the official polling place. The ordi-nance requires a second reading and final vote at an

upcoming council meeting.
Municipal elections in
Foley and most of Alabama will be held Aug. 26, with a potential runoff election scheduled for Sept. 23 if needed. Voters will elect a mayor and five city council members, all serving four-year terms. The mayor will be elected at large, while council members will run

by district.
The council recently approved adjustments to district boundaries to reflect population changes since the last election.

In 2020, city officials moved the polling location to the Foley Event Center, which offered more space for social distancing during the COVID-19 pandemic.

The upcoming election marks the first since the Alabama Legislature ex-tended municipal office terms by one year in 2021 The extension was implemented to prevent local elections from coinciding with presidential or state

The MRF is a 60,000-square-foot facility that will process up to 40,000 tons of recyclables annually. With advanced sorting technology, it separates plastics, paper, metals and cardboard to be baled and sold to recycling mar-The 7.000-square-foot

Waste & Recycling Adven-ture Center will provide a hands-on learning experience for students and visitors of all ages. Visitors can explore recycling through interactive games, a sorting challenge, exhibits explain-ing the recycling process for various waste and learn how landfill gas becomes energy. Comprised of 20 sta-tions on two floors with an overlook of the MRF in operation tours can be scheduled for a wide range of ages, school groups and in-

cled materials," Baldwin County Commissioner Billie Jo Underwood said "The Waste & Recycling Adver ture Center is designed for not only school children to come in and learn, but also adults to gain understanding of waste recycling. Seeing the heart of the MRF. the Green Machine - in ac-tion offers a real-time experience of how recycling works.

At full capacity, the facili-

At full capacity, the facili-ty will create 50 jobs. Constructed by Viridi En-ergy, the RNG plant is adja-cent to Magnolia Landfill and will capture and clean methane gases emitted from the landfill and convert them into natural gas. The "renewed" natural gas will then be piped through a 2-mile pipeline to Riviera Utilities to fuel Baldwin County. The gas-to-energy plant will produce more than 1 million BTUs of nat-ural gas annually, enough energy to heat more than

2,500 homes.
"We recognize the immense potential of develop ing community RNG proj-ects like this one in Baldwin County," said Bill Keller, ex-ecutive vice president of Viridi. "We are confident that this gas-to-energy plant will effectively reduce emissions and create a positive economic impact each year for Baldwin County."

Funding for equipment and facilities was provided through grants from the State of Alabama. Baldwin County Commission allocat ed \$4.6 million of ARPA funds to be used toward the design and construction of the Magnolia MRF. Grants from ADEM helped fund the education facility and equipment within the MRF, and ADECA provided \$2 million in grant funding through the Alabama Saves program for the RNG opera-
