AMENDMENT TO INTERGOVERNMENTAL SERVICE AGREEMENT

This Amendment to the Intergovernmental Service Agreement (the "Amendment") is entered into by and between the Baldwin County Commission (the "County") and the City of Loxley, Alabama (the "City"), as follows:

WHEREAS, the County and the City entered into an Intergovernmental Services Agreement with an effective date of June 1, 2021 (the "ISA"); and

WHEREAS, the ISA formalized the arrangements between the County and the City to provide joint cooperation in the Town's management of the Loxley Transit Shelter project; and

WHEREAS, the term of the ISA was thirty-six (36) months from its effective date; and

WHEREAS, additional time is needed to complete the project forming the basis of the ISA; and

WHEREAS, the Eastern Shore Metropolitan Planning Organization (MPO) allocated \$782,635 in federal funds for the Loxley Transit Shelter; and

WHEREAS, the City agreed to contribute \$195,658 for the 20% local match; and

WHEREAS, additional funds are needed for construction of the project; and

WHEREAS, the ISA may be amended by a written instrument signed by the City and the County; and

WHEREAS, the City and the County desire to amend the ISA and extend the term of the same by twelve (12) months and increase MPO and City funding amounts for the project.

NOW, THEREFORE, premises considered, the City and the County do hereby agree as follows:

- 1. **RECITALS.** The recitals set out above are incorporated into this Amendment as though the same were set out in full in this paragraph.
- **2. AMENDMENT.** Pursuant to Paragraph 15 of the ISA, which permits amendments by written instrument signed by both parties, the City and the County hereby amend the ISA as described in Paragraph 3 of this Amendment.
- 3. TERM EXTENSION. Paragraph 8 of the ISA set the initial term for the ISA to be thirty-six (36) months from the effective date. The City and the County agree to

extend the term of the ISA by twelve (12) months from the conclusion of the initial term.

- 4. PROJECT FUNDING. The MPO has allocated \$1,526,648 in federal funds and the City agrees to contribute \$381,662 for the 20% local match. Of the \$1,526,648, federal funds of \$161,574 have been requested and are pending.
- 5. REMAINDER OF ISA LEFT UNCHANGED. The City and the County only agree to extend the term of the ISA as described in Paragraph 8 of the ISA. All other terms and provisions of the ISA remain in full effect.
