One panel (repeated at each location) will provide an overview of the commemoration and general Baldwin County history; the other will provide information on the county's role in the important events of the early statehood period and the critical role Blakeley and the surrounding area played in the Civil War's Campaign for Mobile, where some of the largest and most consequential battles of the war in the state were waged.
