#### **(SPANISH FORT SCHOOLS)**

The Baldwin County Commission, Baldwin County, Alabama, has ordered a special election in accordance with the petition and request filed by the Baldwin County Board of Education requesting that a special election be held on September 17, 2019, to determine whether or not a special school tax in District 7 (Am. 382) School Tax District in Baldwin County, Alabama, shall be levied and collected in Baldwin County.

State law requires that such special elections be conducted in accordance with the general election laws and special provisions governing school tax elections. Applicable State law, including but not limited to, Ala. Code §16-13-180, et seq., (1975) requires that the County Commission appoint certain election officials, including but not limited to, one returning officer and three managers for each precinct.

At this time, the County Commission must appoint the returning officers and managers and ratify the election officials approved by the Baldwin County Appointing Board in accordance with Ala. Code § 17-8-1, et seq., (1975).
