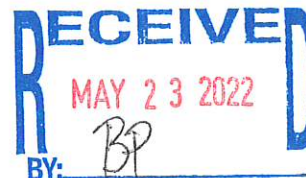

2     ENROLLED, An Act,

3             To alter, rearrange, and extend the boundary lines  
4     and corporate limits of the municipality of the City of Bay  
5     Minette in Baldwin County.

6     BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

7             Section 1. The boundary lines and corporate limits  
8     of the municipality of the City of Bay Minette in Baldwin  
9     County are altered, rearranged, and extended to include within  
10    the corporate limits of the municipality, in addition to the  
11    lands now included, all of the following territory:

12            I-65 and Rabun Road Annexation Property Legal  
13    Descriptions:

14            Cougar Oil, PIN# 93592

15            Commencing at the Southwest corner of the Northwest  
16    Quarter of Section 15, Township 1 South, Range 3 East, run  
17    North 89 degrees 50 minutes 30 seconds East, 2127.94 feet to  
18    a rebar and the POINT OF BEGINNING; Thence continue North 89  
19    degrees 50 minutes 30 seconds East, 182.78 feet to a rebar;  
20    thence run South 11 degrees 49 minutes 31 seconds West, 268  
21    feet to a rebar; thence run North 78 degrees 10 minutes 29  
22    seconds West 169.62 feet to a rebar; thence run  
23    Northwestwardly along the arc of a curve to the right of way  
24    of Old Jack Springs Road, an arc distance of 230.49 feet to  
25    the point of beginning.

12 approval by the Governor, or its otherwise becoming law.
