RESOLUTION OF THE COUNTY COMMISSION OF BALDWIN COUNTY, ALABAMA FOR THE VACATION OF AN UNOPENED, UNIMPROVED 20 FOOT RIGHT OF WAY WEST OF S. CEDAR STREET

RECITALS:

1. Michael J. Woerner and Caryn H. Woerner are the owners and holders of interest of the lands abutting a 20' unopened, unimproved Right of Way west of S. Cedar Street, more particularly described as follows:

Beginning at a 1" Crimped top iron pipe at the southeast corner of Lot 6, Parkwood Subdivision, as shown on plat thereof recorded on Slide 1153-B in the Office of the Judge of Probate, Baldwin County, Alabama; thence run North 00°08'32" East along the east line of said Subdivision a distance of 20 feet to a point; thence leaving said east line run South 89°57'24" East a distance of 308.99 feet to a point on the west right of way of Cedar Street (60' wide R.O.W.); thence run South 00°07'01" West along said west right of way a distance of 20 feet to a point; thence leaving said west right of way north 89°57'24" West a distance of 308.99 feet to the point of beginning, lying in the Northeast Quarter of the Southwest Quarter of Section 29, Township 7 South, Range 4 East, Baldwin County, Alabama.

- 2. Daniel L. Kittrell is the owner of the land at the terminus of the above described Right of Way. Together, Daniel L. Kittrell, Michael J. Woerner, and Caryn H. Woerner are referred to herein as "Petitioners".
- 3. The Petitioners have filed a Petition with the County Commission of Baldwin County, Alabama (the "County Commission") requesting that the County Commission adopt a resolution to vacate the Right of Way.
- 4. The Petitioners, pursuant to Section 23-4-2, et. seq., <u>Code of Alabama 1975</u>, desire to destroy the force and effect of the dedication of the <u>Right of Way</u> and divest all public rights, including any and all rights which may have been acquired by prescription in and to the Right of Way.
- 5. The Right of Way is located within the City of Foley, Alabama, but is owned by Baldwin County, Alabama. The City of Foley has not accepted, improved, or maintained the Right of Way and has no claim or interest therein. The City of Foley's letter disclaiming any interest in the Right of Way is attached hereto as Exhibit "A".

- 6. It is in the interest of the public that the Right of Way be closed and vacated.
- 7. The vacation of the Right of Way does not deprive other property owners of such rights as they may have to convenient and reasonable means of ingress and egress to and from their property.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSION OF BALDWIN COUNTY, ALABAMA, that the County Commission does assent to the vacation of the Right of Way described in Paragraph 1 of this Resolution and, as such, the Right of Way is hereby vacated and annulled and all public rights and easements therein are divested.
