Exceptions: Moyer Bid Response stated "We regret that we are unable to bid this unit as specified in the bid specifications. They state ordering has been cut off by Ford for retail, fleet and government orders for 2023 Expedition. Four (4) Alternate options offered and bid specs required Black Metallic exterior, Moyer Ford offered 2 colors, Forged Green Metallic & Dark Matter Gray Metallic, bid specs required 22" wheels with 12-spoke polished aluminum, Moyer Ford offered 18" Magnetic-Pntd Alum Wheels, bid specs required Equipment Group 600A, Moyer Ford offered Equipment Group 501A. The Timberline model is more of an off-road vehicle with a heavy duty radiator and interior tangerine stitch accents. The other two (2) options offered are 2023 Ford Expedition Max XLT 4x2 and Limited Stealth 4x2, both did not meet bid specifications or equivalency. Delivery time stated in specs was 10 days. Moyer Ford's estimated delivery time on the XLT Expedition model was 20 -30 days. The bid submitted by Moyer on the Stealth Expedition has an estimated delivery time of 30-60 days.
