BEGINNING at a concrete monument at the Southwest corner of the Northwest Quarter of the Northeast Quarter (NW ¼ of NE ¼) of Section 12, Township 2 South, Range 2 East; run thence North 89° 51' 25" East, 631.80 feet to a concrete monument; run thence South 00° 36' 06" East, 1320.00 feet to a concrete monument; run thence South 89° 51' 25" West, 1980.00 feet to a concrete monument; run thence North 00° 36' 06" West, 1320.00 to a concrete monument; run thence North 89° 51' 25" East, 1348.20 feet to the **POINT OF BEGINNING**, containing 60 acres, more or less.

Grantee by its acceptance of this deed acknowledge that there is no current environmental contamination on or to the soil and groundwater of the property being sold and conveyed hereunder, and undertakes the responsibility of any necessary clean up requirements in the future for contamination which may result as a consequence of the landfill which the GRANTEE, its successors and assigns, intends to build, or allow to be built, constructed and operated on the subject property. The GRANTEE further hereby agrees to indemnify and hold harmless International Paper Company, Sustainable Forests, L.L.C. and any affiliate of either of those two entities from and against any and all liabilities, losses, fines, penalties, or clean up requirements to the extent the same are incurred as a result of environmental contamination of the groundwater or soil of the property, as a result of the construction, operation, closure or post closure of a landfill on the subject property.

This conveyance is subject to the following:

1. The prior reservation to International Paper Company, its successors and assigns, of oil, gas, and associated hydrocarbons, and all other minerals mineral substances, and mineral deposits of any kind or character, whether solid, liquid, or gaseous, together with executive rights, full rights of ingress and egress, and use of the surface to the extent reasonably necessary for the purposes of exploring, developing, producing, and transporting these minerals and mineral rights.

This conveyance is subject to all outstanding oil, gas and other mineral and/or royalty rights and interest of record on any of said lands.

- 2. Any state of facts which would be revealed by an accurate survey and/or careful inspection of the Premises, including but not limited to boundary line disputes.
- 3. All easements for roadways, and public utilities installations and all other matters of record or in possession or use, as well as any defects, encroachments or boundary line disputes which would be shown by an inspection or competent survey of the subject lands.
- 4. Ad valorem taxes for the year 1998 shall be paid by the Grantor. All taxes thereafter shall be the responsibility of the Grantee.

TO HAVE AND TO HOLD the within described property, together with the privileges and appurtenances thereunto properly belonging, and subject only to the exceptions, reservations and restrictions herein contained and referred to, unto the Grantee, its successors and assigns forever.
