**Scope of Work (Option # 1)**

- Provide and Install additional light gauge framing to support additional panels
- Provide and Install closure strips between existing panels and new panels
- Provide and Install new panels to extend approximately 8" past the edge of the concrete
- Provide Baldwin County Commission with 3 year contractor's warranty

*With this option, we will attempt to match the existing profile and color. However, we cannot guarantee a perfect match because of fading and age of existing panels.*

**Scope of Work (Option # 2)**

- Remove existing panels and turn back to the County Commission or properly dispose
- Provide and Install additional light gauge framing to support new panels
- Provide and Install closure strips between new panels as needed
- Provide and Install new panels to extend approximately 8" past the edge of the concrete
- Provide Baldwin County Commission with 3 year contractor's warranty and Manufacturer's 10 Year Warranty including Hail Damage

**We hereby propose to:**

- Install cross bracing at each section to support new translucent skylight panels.
- Remove screws from bottom of existing panels in order to slide new under at end laps.
- Install new translucent panels across the entire outside edge of the cover stalls including the entire area on the south end.

---

**Excluded from this proposal:**

- Any replacement of damaged or defective framing, blocking, and sheathing.
- Any replacement of existing perimeter metals such as copings, eave flashings at the shingle roofs, or counterflashing's.
- Any replacement of existing panels.
- Any work on any roof areas not indicated on the roof layout below
- Any performance bonds.

---

**Notes:**

- Permits are not included in this proposal.
- AL state sales tax is included in this proposal.
- Performance and payment bonds are not included in this proposal. If needed add, 1.5% or a minimum of \$500.00.
- ECMC plans to access these roofs from the exterior of the building.
- Customer to allow access for forklifts and dumpsters and laydown yard of at least 3,000 sf.


