The subject property is currently B-4. And the applicant is asking that it be re-zoned to RSF-E. The purpose of this request is that they -- they plan to refinance their home because of a medical issue, and they need the residential zoning in order to do this.

The subject property was originally zoned RSF-E when Planning District 12 became zoned in 2006. In 2014, the applicant had requested that this be re-zoned to B-4. Staff recommended denial, because they thought it was premature for this area right here. But, ultimately, it was approved by the County Commission.

As far as traffic or anything, the whole -- this
Oakdale Drive, it's all residential. There is currently
a home and an accessory structure on the subject
property.

Staff sees no issues with this going back to RSF-E and recommends approval.
