





Onesimus. We encounter this odd and obscure character with the odd and obscure name, which is difficult both to pronounce (Oh-NES-imus) and spell, in Paul's letter to Philemon. Onesimus is Philemon's slave. Something (we are not sure what) has gone wrong between this slave and his master. Either Onesimus has run away, or he has come to Paul to make accusations about his treatment by Philemon (who is a Christian and house church leader), or some combination of the two. The letter reveals two actions by Paul, First, Paul leads Onesimus to find forgiveness. life, and true freedom in Jesus Christ. This makes Onesimus Paul's "son" in the faith; no longer a slave, he is now a family member. Second, Paul sends Onesimus back, urging Philemon to show grace and to receive Philemon as a brother in the household of faith. Interestingly, Paul does not address the issue of Onesimus's cultural status as a slave. For Paul, once King Jesus takes control, all of the worldly kingdom's designations and assignments are out. Paul doesn't tell Philemon to let Onesimus go (which is what, from our modern perspective, we might expect or even demand that Paul should do)

because then Onesimus would have

no family, no identity-he'd just be some else's problem (which is also how we tend to "solve problems" in our modern context). Instead, Paul instructs Philemon and Onesimus to figure out how the kingdom of God should work itself out in their lives together as members of the same family with the same status before God. And apparently, they were able to figure it out. Ignatius of Antioch tells us that, fifty years later, a certain Onesimus was the bishop over the whole church in Ephesus: the slave became the leader of the most influential group of believers of that era. The gospel changed the way Philemon and Onesimus saw themselves and each other-and that changed the world.

She has been training there ever since. She trains and competes in all four events including vault, uneven bars, balance beam, and floor exercise. Brie fell in love with gymnastics because of its challenges and the sisterhood that is formed between her and her teammates. To date, Brie trains

22 hours per week at Planet Gymnastics under coaches Vladimir Novikov and Melanie Fuller. With their help and guidance, she is working to be the best gymnast she can be with future aspirations to be a Division 1 college gymnast. With their encouragement and supreme coaching she hopes to go far in this sport. Her coaches and teammates view her as a leader, role model, and mentor. Though mild mannered and softly spoken, Brie has become a fierce competitor and team motivator.

After joining the Planet Gymnastics competitive team, Brie's natural talent and hard work began to pay off as a level 7 gymnast in

2014 when she placed eighth in the all-around. first on vault and fifth on floor at the Alabama State Championships. She qualified to the Region 8 Championships (which includes multiple competitors from eight different states) where she placed twelfth overall and ninth on vault. Brie moved up to level 8 for the 2015 season. At the State Championships, she placed sixth in the all-around and sixth on vault, bars and floor. She again qualified to the Region 8 Championships, finishing 11th in the all-around with a score of 37.000, 5th on vault and 7th on floor.

While Brie has experienced much success in her gymnastics career, these successes are not without struggles. She missed nearly two full competition seasons due to injuries and recovery, but this never stopped her from training. 
any flags that fell over.

"American flags should never be allowed to touch the ground," he said, "and any flag that does will be replaced with a new flag."

In addition, cadets hoisted a POW/MIA flag in remembrance of the 7,704 unaccountedor Americans of the Korean War. Above that was hoisted a full-sized American flag that flew over the Capitol building in Washington, D.C., donated by U.S. Rep. Bradly Byrne's office.

Since they began setting up the display on Monday, Meehan said, the response from the public has been overwhelming.

"People have been driving by honking and waving," he said. "It's just been incredible."

history to determine the amount of opioid related drugs that have been purchased. Another area of prevention Marshall spoke of was teaching the younger generations the consequences of opioid abuse, and for adults to understand how easy it can be for children to obtain a controlled substance. Whenever a patient gets a common procedure done, such as getting a wisdom tooth pulled, pain medication is prescribed and taken home.

"Young people have access to these drugs because they're sitting in their medicine cabinets," said Marshall. "We have to be able to have safe storage, safe usage, and safe disposal

of these medicines."

The second area that Marshall spoke about concerned breaches of data and identity theft, issues that have become all too common in the digital era.

"Unfortunately Alabama was, until the most recent legislative session, the only state in the union that if there was a data breach, a company did not have to notify you of that fact," Marshall said. "Some companies used good business practice, and I appreciate that, but yet 49 other states were out there who said that if your personal informa tion is taken, you need to know about it.

During the last legislative session, the Alabama Data Breach Notification Act was passed, which will make it so if ever there is a data breach, customers or people who may be affected legally must be notified. This will allow them to discover any breaches in their security early on, and quickly deal with the situation.

The final thing that Marshall spoke about concerned bringing the voices of the state together as one on revisions to the Alabama

Ethics Laws.
"Ethics laws violations are really just crimes with a different name," Marshall said.
"Legislation passed a bill to allow the formation of a commission to be able to reform and clarify the direction of our current ethics laws."

A major point in Marshall's discussion concerned a recent ethics bill that passed that exempts economic development consultants from a requirement to register as lobbyists with the Ethics Commission unless they seek special incentives for their clients. Those who are against this exemption state that placing such restrictions on potential business owners

"That exemption is going to expire in April of next year, and as we move towards ethics laws, that's going to be an initiative," Marshall said. "We need people to be engaged so your voices are heard, for one because of how economic development is important, but also how it can impact our communities to bring good jobs to the state ... We need voices to be heard. I'm going to be a champion for this, but I'm only one voice."

One Life-Changing Confrontation

Onesimus. We encounter this odd and obscure character with the odd and obscure name, which is difficult both to pronounce (Oh-NES-imus) and spell, in Paul's letter to Philemon. Onesimus is Philemon's slave. Something (we are not sure what) has gone wrong between this slave and his master. Either Onesimus has run away, or he has come to Paul to make accusations about his treatment by Philemon (who is a Christian and house church leader), or some combination of the two. The letter reveals two actions by Paul. First, Paul leads Onesimus to find forgiveness, life, and true freedom in Jesus Christ. This makes Onesimus Paul's "son" in the faith; no longer a slave, he is now a family member. Second, Paul sends Onesimus back, urging Philemon to show grace and to receive Philemon as a brother in the household of faith. Interestingly, Paul does not address the issue of Onesimus's cultural status as a slave. For Paul, once King Jesus takes control, all of the worldly kingdom's designations and assignments are out. Paul doesn't tell Philemon to let Onesimus go (which is what, from our modern perspective, we might expect or even demand that Paul should do) because then Onesimus would have

no family, no identity-he'd just be some else's problem (which is also how we tend to "solve problems" in our modern context). Instead, Paul instructs Philemon and Onesimus to figure out how the kingdom of God should work itself out in their lives together as members of the same family with the same status before God. And apparently, they were able to figure it out. Ignatius of Antioch tells us that, fifty years later, a certain Onesimus was the bishop over the whole church in Ephesus: the slave became the leader of the most influential group of believers of that era. The gospel changed the way Philemon and Onesimus saw themselves and each other-and that changed the world.
