Both the Huskies (Pac-12) and the Tigers (SEC) are at the top of their respective conference with great offensive philosophies and tough defenses. Auburn is led by Jarrett Stidham, who is a preseason Heisman Trophy finalist favorite from many College Football analysts. He will need to make excellent reads and perform in a high-level against a Huskies defensive unit that is arguably one of the best.

The Huskies return all of their starting defensive backs from a defense that was ranked fifth in points allowed per game (16.1). The Tigers do not have an experienced running back but their receiver corps will be needed more. Ryan Davis and Darius

performance against this highly talented Huskies defensive backfield.

The Tigers defensive line, led by Marlon Davidson and Dontavius Russell, might be the most crucial position group against Washington. They will need to clog the running room of the Huskies O-line, which returns four starters as Myles Gaskin will be a tough back to stop. Last year, Gaskin ran for 1,380 yards and 21 touchdowns from 222 rushing attempts. The Auburn Tigers came out of the weekend as a 2.5 point favorite over the Washington Huskies.
