Baldwin EMC crews to assist Florida Co-op in power restoration

SUMMERDALE -Baldwin EMC is sending 15 employees to assist Gulf Coast Electric Cooperative, headquar tered in Wewahitchka, Florida, in power restoration efforts following Hurricane Michael. The crews departed from the co-op's Summerdale headquarters at 5:15 a.m. on Thursday, Oct. 25, and will include construction crews, service men and transportation employees

Baldwin EMC crews began preparing for departure Wednesday afternoon, packing food, water and other neces-

"Our crews are eager to assist our sister coops in these situations," said Baldwin EMC CEO Karen Moore. "As everyone who lives in our region knows, with hurricanes it's never a matter of 'if' but of when.' We are always glad for the opportunity to send crews and share our resources with other cooperatives in need of assistance, and we're grateful to be a part of a community of mutual aid."

GCEC provides electric service to more than 20 000 electric accounts over 2,500 miles of line in six counties in the panhandle of Florida.

Located east of Panama City, the cooperative's distribution system suffered catastrophic damage from Hurricane Michael. Up to 49 percent of the co-op's meters are still without electricity.

Baldwin EMC crews worked in the Dothanarea assisting Wiregrass Electric Cooperative restore power following Hurricane Michael, and eight workers are currently assisting Three Notch Electric Co-op in Donalsonville, Georgia, in addition to the crews heading to Florida.

Baldwin EMC is part

of a nationwide network of electric cooperatives that assist each other in times of natural disasters. Baldwin EMC has provided assistance numerous times to other cooperatives across the southeast following hurricanes, tornadoes and ice storms.

Homework boxes at BMES

BAY MINETTE - The homework box has been activated for students in Shana Harville's class at Bay Minette Elementary.

The concept is simple: students bring in a shoebox and the teacher fills it with notebook paper, sharpened pencils, erasers and decodeable text on their level and replenishes the supplies as needed. The students then have to be proactive and take responsibility for their homework each night using the materials.

Harville encourages the students to store the boxes in a safe place and to put "first things first" and do homework before playing.

"It takes away some excuses and takes away the pressure on the parent to get it done," she said. "They keep up with how many nights a week they do homework without being prompted by adults, Simple, I know, but they love it. Some of my second graders are still using theirs."

Open house for proposed Wolf Bay Bridge draws more than 200 people

More than 200 people turned out Monday, Oct. 22 for the public information meeting on the proposed Wolf Bay Bridge project, which will connect State Highway 161 to County Road 95 over the bay.

The open house-style meeting was held from 4 to 7 p.m. at the Orange Beach Community Center and was an opportunity for the public to get information and submit written comments on the project. Anyone who was unable to attend the meeting and would like to comment, can print a Wolf Bay Bridge Project comment form (available on the city's website) and mail it (postmarked on or before Tuesday. An information page on the proposed Wolf Bay Bridge also included the following information:

Introduction .

The City of Orange Beach is proposing a project consisting of a two-lane roadway with new bridge over the Gulf Intracoastal Waterway (GIWW) at Wolf Bay.

This project, to be funded through the 2 percent lodging tax approved by the city council, will provide a free (i.e. no toll) crossing between Orange Beach and the Back Bay.

Tonight's meeting is a community open house. There is no formal presentation.

This meeting will acquaint you with information being used to apply to a project permit from the U.S. Coast Guard for the project. The exhibits in the room will provide information on the pro-

posed project & characteristics of the study area.

Staff from the city and members of the project consultant team are here this evening to receive comments from the public on potential navigational and environmental effects associated with the proposed project.

Study Area

The study area for the project extends north from AL Highway 161 to County Road 95. This area includes developed land within the City of Orange Beach, as well as undeveloped land on the Back Bay.

Frequently Asked Questions

How long is the current phase of work?

It will take between 12 and 24 months to complete the current phase of work (permits, environmental and engineering) and start construction.



Once construction starts, it will take 30 to 36 months to complete the project.

How will the cost of construction be paid

The cost of construction will be paid for using the proceeds from the city's 2 percent lodging tax approved by the city council. In addition, it is expected that a cooperative endeavor for future land use development on the Bay Back will also help to finance a portion of this project's construction.

Will this bridge have a toll?

No, this project will be paid for using local funds.

What is the format of this meeting?

Members of the public are invited to view exhibits & ask questions of the project team & City representatives. We'd welcome any comments you might have on this project on the attached comment form.
