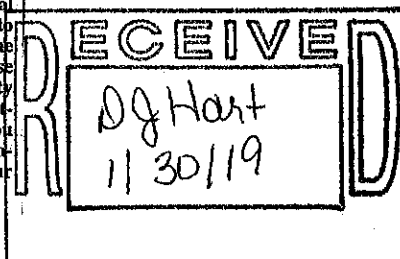

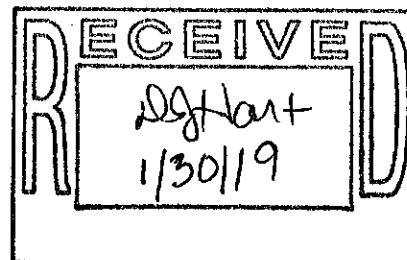

# 'Alabama's Historian' Wayne Flynt to speak at University of Mobile for Alabama's Bicentennial

MOBILE — The University of Mobile College of Arts & Sciences puts the spotlight on Alabama's bicentennial with a free lecture by "Alabama's Historian" Dr. Wayne Flynt.

Flynt, professor emeritus of history at Auburn University, will deliver a lecture entitled "Pulitzers and Politics: The Best and Worst of Alabama on Our 200th Birthday." The event will take place on Wednesday, Jan. 30 at 7 p.m. in the newly-renovated Weaver Auditorium on the University of Mobile campus. The program, which will include a book signing, is free and open to the public.

Flynt has been referred to as "Alabama's Historian." He is the author of 11 books, two of which were nominated for the Pulitzer Prize. His work spans topics including evangelical religion, poverty, Alabama history, and literature. His memoir, *Keeping the Faith*, was published in 2011. He has been an invited lecturer at institutions around the world including Cambridge and Oxford universities. He has also been the subject of two Alabama Public Television documentaries and in 2000 was awarded the Doctor of Humane Letters by Samford University.

Flynt attended Samford University as a ministerial student where he double majored in history and speech. He received his Ph.D. in American history from Florida State University. During his 40-year teaching career at Samford and Auburn, he won 18 teaching awards. In 1991, he was selected as Alabama Professor of

the Year by the Alabama Council for Advancement and Support of Education.

In addition to his scholarly activities, Flynt has been recognized for his outstanding record of political and civic activism, including being named by the Mobile Register as Alabamian of the Year in 1992.

ine Ibarguen, track and field, Colombia; Ariya Jutanugarn, golf, Thailand; Chloe Kim, snowboarding, United States; Ester Ledecka, skiing and snowboarding, Czech Republic; Marta, soccer, Brazil; Mikaela Shiffrin, skiing, United States; Breanna Stewart, basketball, United States.

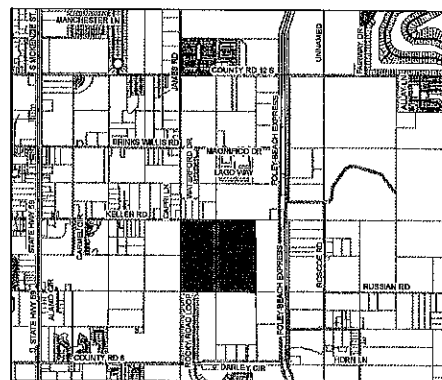

# Fish fry fundraiser held for Masters Games

**ROBERTSDALE** — The George P. Thames Adult Activity Center held a fish fry fundraiser on Friday.

Plates included fried fish, hush puppies, Cole slaw, baked beans and pound cake. Proceeds from the fundraiser will help send a team to this year's Masters Games of Alabama, which will be held in October.

Every year the Center takes a group to participate in the games. In 2018, the Activity Center sent 12 participants to the games, who brought home eight medals, including three gold.

According to the East Alabama Regional Planning and Development Commission Website, the Masters Games of Alabama is a non-profit organization dedicated to promoting healthy life-

styles for active adults age 60 and over through social, mental and physical activities.

They were developed in Oxford in 1989 to provide adults age 50 and above an opportunity to maintain an active lifestyle by participating in a variety of events. Each year, between 600 and 800 participants and volunteers from across the state participate in the games.

The Adult Activity Center also hosted an indoor/outdoor yard sale and bake sale Saturday, Jan. 5 to raise money for the Masters Games.

Practice for this year's games begins at 9 a.m. Wednesday, Jan. 9 at the Adult Activity Center, 22651 E. Chicago St., Robertsdale. Anyone who is eligible to participate in the games is welcome to take part. Practice will include shuffleboard, frisbee,

nerf toss, horseshoes, along with other games. Another practice is scheduled for 9 a.m. Wednesday, Jan. 30 at the Adult Activity Center.

This will be the 14th straight year participants from the Thames Center will participate in the games, sponsored by the Area Agency on Aging, also locally by the South Alabama Regional Planning Commission.

The Thames Center represents District 7, which includes Baldwin, Mobile, Escambia, Conecuh, Washington, Choctaw, Clarke, Wilcox and Monroe counties. Participants also attend locally from Orange Beach, Saraland, Chikaskaw and Mobile. District qualifying for this year's Masters Games begins in the Spring.

The Thames Center serves Robertsdale, Loxley and Silverhill in Cen-
