The goal of this Solid Waste Authority Feasibility Study would be to identify and evaluate opportunities to increase the efficiency and effectiveness of the County's solid waste services by the formation of a Solid Waste Authority.

- Phase 1 Project Initiation The purpose of this Phase will be to meet those members of the solid waste department and Baldwin County Commission that would be impacted by the results of the Study.
- ❖ Phase 2 Data Gathering The purpose of this Phase will be to acquire relevant statutory, regulatory and other information required to analyze solid waste authorities in Alabama. Information will include pertinent laws, regulations and other facts relevant to Baldwin County.
- ❖ Phase 3 Analysis The purpose of this Phase will be to analyze the information collected and evaluate it for opportunities to maximize improvements and optimize efficiencies/effectiveness for Baldwin County.
- ❖ Phase 4 Report and Presentation A final printed report and presentation would be presented and reviewed with appropriate County personnel. Topics of the final report will include:

## METHODOLOGIES & PROPOSAL CONDITIONS

The Consultant warrants to County for a period of one (1) year following delivery by Consultant of its final approved work product (the "Warranty Period") and that the work performed herein shall be in accordance with good business practices and standards established for such work of a similar nature. Consultant's liability in regard to the corrections of any deficiencies in the work attributable to consulting services performed herein during the Warranty Period shall be limited to revision or re-performance, without charge, of any work performed under this Agreement that can be shown to be faulty. The foregoing warranties and remedies for breach thereof are exclusive and conditioned upon timely notification within the Warranty Period by County. Consultant gives them in lieu of any and all other remedies, guarantees, and warranties, express or implied. There is no warranty of merchantability nor warranty of fitness for a particular purpose. The warranties and rights herein are County's exclusive rights under the Agreement.

In the event the County implements strategies or makes business decisions based on any opinions, advice or assistance of EBS, the County does so at its own risk and without any recourse against EBS. Likewise, the County hereby releases EBS from any and all liability flowing from the County's declining to follow any advice or recommendations of EBS. In any event, EBS shall not be liable for any indirect, consequential, special, incidental, and/or punitive damages of any kind or nature under any circumstances. To the extent allowed by law, the County shall indemnify, defend, and hold harmless EBS from and against all loss, liability, claim, damage (including incidental and consequential damages) or expense (including costs of investigations and defense and reasonable attorney's fees) whether or not involving third party claims, arising directly or indirectly from or in connection with any breach by EBS or by the County of any terms of this Agreement, EBS's performance of the Services, or otherwise relating to the County, but excluding acts of EBS's negligence or willful misconduct. 
