



The City of Gulf Shores is excited to announce the upcoming Meyer Park Improve ment Project, which will improve and reconfigure the existing Meyer Park playground area located in the Waterway Village District at 400 East 22nd Ave. The current playground area at Meyer Park will be closed for demolition and construction beginning Monday, March 4.

The Meyer Park Im-

provement Project will include replacing the playground, pouring new sidewalks with benches and re-sodding open areas near the pavilion and restrooms. In addition, the park will feature new recycling containers as part of the city-wide recycling initiative.

"We feel this project will not only spruce up Meyer Park, but also enhance resident experience, greatly increase play area safety and steam-line area main-

tenance," Recreation & Cultural Affairs Assistant Director Matt Young said.

The estimated completion date for the Meyer Park improvements is April 2019. The pavilion, horseshoe pits and open grass fields will remain open to the public during the construction period.
