The destination of RV-1, Recreational Vehicle Park District has been requested for the purpose of establishing an RV park with amenities and small country store.

This application was originally submitted as a request for B-4, Major Commercial District, and was recommended for approval on November 1, 2018. It has been returned to the Planning Commission in order to be re-advertised as a request for RV-1, Recreational Vehicle Park District.

The subject property is located at 28379 US

Highway 98 in Planning District 22. The adjoining

properties are residential, commercial, and agricultural.

There are numerous commercial and industrial zoning

designations in this area.

The Baldwin County Master Plan provides a future land use designation of agricultural for the subject property. Approval of the re-zoning will result in amendment of the Future Land Use Map to commercial.
