DETERMINATION OF THE BALDWIN COUNTY COMMISSION, REGARDING **Case No. Z-19006, Willis Property** SUCH DETERMINATION AS AUTHORIZED PURSUANT TO SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975).

**WHEREAS**, Chad C. Willis has petitioned the Baldwin County Commission to rezone certain property, in Planning (Zoning) District No. 25, for property identified herein and described as follows:

**100' X 250' BLK 2 PT OF LOT 5 CHILDRESS LANDS PB302 PG379 BEG AT NE COR OF LOT 5 TH S 250', W 100', N 250' & E 100' TO POB SEC 20-T9S-R3E (QCD)**

and

**142'X250' BEG 100' W OF NE COR LOTS BLK 2 CHILDRESS LAND TH S 250' W 142' N 250' E 142' TO BEG SEC 20-9-3 (QCD)**

Otherwise known as tax parcel numbers, **05-67-04-20-1-001-015.000 and 05-67-04-20-1-001-015.001**, as found in the office of the Revenue Commissioner of Baldwin County, Alabama; and

**WHEREAS**, the petitioner has requested that the property herein identified be rezoned from RSF-1, Single Family District, to RSF-2, Single Family District; and


**WHEREAS**, the Baldwin County Planning and Zoning Commission held a public hearing on February 7, 2019, and voted to recommend approval of the rezoning request; and

**WHEREAS**, the Baldwin County Commission held a public hearing on March 19, 2019; and

**WHEREAS**, the requirements of SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975), regarding procedures to consider this rezoning request, which would affect the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 25 Official Map, have been met; now therefore

**BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED**, That the petitioner's request to rezone the property (Case No. Z-19006, Willis Property) as herein identified and described and as found within the confines of Planning (Zoning) District No. 25 from RSF-1, Single Family District, to RSF-2, Single Family District which amends the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 25 Official Map, is hereby **APPROVED**.
