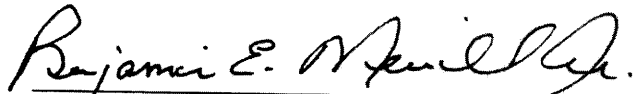
AMENDED PETITION FOR FAMILY CEMETERY

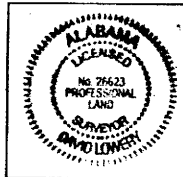
