## Robertsdale FD to donate gear for education

ROBERTSDALE -Thanks to a unanimous vote of the Robertsdale City Council at its meeting on Monday, May 20. the Robertsdale Volunteer Fire Department will be donating some of its equipment to help educate students.

The council introduced new fire chief Nick Moore during the council meeting and voted to surplus miscellaneous equipment for the fire department. with plans to replace it

with new equipment, including:

- 10 sets of turnout gear. Five SCBAs (selfcontained breathing apparatus)
- Five SCBA bottles.

At the same time, the council voted to allow the fire department to donate the gear to the South Baldwin Center for Technology's Fire Science Program.

Included in the information packet provided for the meeting was a request by SBCT Fire Science Program instructor Melvin Stringfellow.

"Here at South Baldwin Center for Technology we have benefitted from RFD generosity." he said. "The donations of used PPE and SCBAs have helped sustain the

Fire Science Program." In other business May 20, the council voted to amend the city's zoning ordinance to rezone property located at Alabama 59 and County Road 54 from I-1 (industrial) to B-2, general

City engineer Greg Smith told council members that the property was probably zoned

I-1 because of its close proximity to the city's Industrial Park and by rezoning it to B-2, it would be more in line with other properties in the area.

The rezoning request was recommended for approval by the city's Planning Commission. Also on May 20, the council:

- Approved a request to hold the annual Tenley Tough 5K in October. No official date has been set for the event.
- Approved a request to use the city's digital

billboard to advertise the annual Memorial Day Flag Relay. The event was scheduled to run Monday, May 27 from Daphne, along U.S. 90 to Loxley and along Alabama 59 from Loxley through Robertsdale to Foley. A second flag relay would run from Foley to Orange Beach. Participants will be taking donations for the event with proceeds to

Bicentennial scholar and author, Mike Bunn, will be returning to the Foley Public Library to give a presen-tation on the "Creek War & War of 1812" as it concerns the state of Alabama. Bunn gave a presentation back in January 2019 on the tumultuous beginnings of the state. His presentation was so well received, he has been invited back on Tuesday, June 4, at 2 p.m., to discuss this further history of Alabama

Bunn is a public historian who has spent the entirety of his career researching. writing, and speaking

about the Deep South's history and culture. He is author of several books on Alabama. Georgia, and Mississippi history, and a frequent contributor to publications such as Alabama Heritage magazine.

Bunn is currently Director of Operations at Historic Blakeley State Park in Spanish Fort, a 2,000-acre site within the scenic Mobile-Tensaw Delta preserving the sites of the territorial-era town of Blakeley, the Civil War Battle of Fort Blakeley, and colonial era and Native American occupations

#### ORDINANCE NO. 006-19

AN ORDINANCE TO AMEND ORDINANCE NO. 02-10, ADOPTED BY THE CITY COUNCIL OF THE CITY OF ROBERTSDALE, ALABAMA, SEPTEMBER 23, 2002.

BE IT ORDAINED, by the City Council of the City of Robertsdale, Alabama as

That the Zoning Ordinance and official zoning map as amended, be further amended to rezone the following described property:

<u>FROM I-1 to B-2;</u> THE WEST HALF OF THE NORTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 5 SOUTH, RANGE 3 EAST, LESS AND EXCEPT THE FOLLOWING: (A) BEGIN AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER

OF THE SOUTHEAST QUARTER, SECTION 36, TOWNSHIP 5 SOUTH, RANGE 3 EAST, AND RUN THENCE EAST 316 FEET TO A POINT, WHICH IS THE POINT OF BEGINNING OF THE PARCEL HEREBY EXCEPTED; THENCE RUN SOUTH 310 FEET TO A POINT; THENCE RUN EAST 250 FEET, MORE OR LESS, TO A POINT ON THE WEST RIGHT-OF-WAY LINE OF U. S. HIGHWAY 90; THENCE RUN NORTHWARDLY ALONG THE SAID HIGHWAY RICHT-OF-WAY 310 FEET TO A POINT; THENCE RUN WEST 250 FEET, MORE OR LESS, TO THE POINT OR PLACE OF BEGINNING.
(B) A STRIP OF REAL PROPERTY 30 FEET IN WIDTH RUNNING ALONG THE SOUTH LINE OF THE WEST HALF OF THE NORTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 5 SOUTH, RANGE 3 EAST. (C) BEGINNING AT THE SOUTHWEST CORNER OF THE SOUTH HALF OF

THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 5 SOUTH, RANGE 3 EAST; THENCE RUN NORTH 320 FEET, THENCE RUN WEST TO THE EAST MARGIN OF U. S. HIGHWAY NO. 90, THENCE RUN SOUTH ALONG THE SAID U.S. HIGHWAY 90 TO A POINT DIRECTLY WEST OF THE POINT OF BEGINNING, BEING A STRIP OF LAND 10 FEET WIDE, MORE OR LESS.

BE IT FURTHER ORDAINED THAT THE OFFICIAL ZONING MAP, AS AMENDED, BE FURTHER AMENDED TO REFLECT THIS CHANGE.
