**Directive Changes** 

The cost to make changes as of 6/24/19:

 Add hardwood casing and back band to 3 each H.M. door frames. Stain and finish to match wall panel color.

Add: \$1,372.70

 Add 5/8 F.C. drywall to exposed studs on east wall where existing panels were removed and underlying drywall was missing, tape and finish.

Add: \$381.20

Add stabilizing concrete wedge anchors to existing wall plate as directed.

Add: \$169.25

 Change wood floor carpet underlayment to ½" in lieu of ¼", add end return on existing jury front screen wall.
