

## **BID #WG20-52A SPECIFICATIONS**

These specifications shall be construed as minimum. Should manufacturer's current published data or specifications exceed these, such standards shall be considered minimum and furnished. All integral parts not specifically mentioned in the scope of these specifications that are necessary to provide a complete working unit shall be furnished. The equipment must be a current production model. If equal models are bid the substituted equipment must be current production models.

The use of specific names and numbers in the specifications is not intended to restrict the bidder or any seller or manufacturers, but is solely for the purpose of indicating the type, size and quality of equipment considered best adapted to Baldwin County.

## **GENERAL**

The following specifications provide the data necessary for vendors to submit bids for Push-To-Talk over Cellular (PoC) Services & Equipment that will be utilized by various departments within Baldwin County.

If an "or equal" item is bid, it will be the Bidder's responsibility to prove that "or equal" item is in fact equal. If an "or equal" item is bid, the Bidder will be responsible for providing one device of each model along with any related software for demonstration purposes, prior to the bid award. Specifications listed highlight important features, but do not constitute full specifications used to determine "or equal" acceptance.

## **AWARD**

Award will be made to the lowest responsible bidder meeting the bid specifications. It is the County's intent to award the bid to one vendor.

It is the intent of the Baldwin County Commission to award this contract for a twenty-four (24) calendar month period. However, the Baldwin County Commission may, at their option and in agreement with the Successful Bidder, renew the contract for up to one (1) additional year at the same prices and terms as in the original contract. The Baldwin County Commission will, in writing, notify the Contractor thirty (30) days prior to expiration of the contract with its' intention to extend the contract.

Installation of the radios will be performed by Baldwin County personnel. Required hardware shall be shipped with the units.
