## RESOLUTION

COMMENDING LEIUTENANT HARLEN HILL UPON THE OCCASION OF HIS  
RETIREMENT AS LIEUTENANT OF THE BALDWIN COUNTY SHERIFF'S OFFICE AND  
FOR HIS YEARS OF DISTINGUISHED PUBLIC SERVICE.

WHEREAS, Lieutenant Harlen Hill began his career as a Deputy Sheriff under Sheriff James B. Johnson in August of 1989; and

WHEREAS, Lieutenant Hill graduated from the Alabama Peace Officers Standards & Training Commission (APOSTC) in 1988; and

WHEREAS, Lieutenant Hill completed and was a part of the 1<sup>st</sup> organized Emergency Response Team (ERT), now known as SWAT, in 1991; and

WHEREAS, Lieutenant Hill was assigned to the Interdiction Unit of Narcotics where he was recognized as Narcotics Officer of the Year for the State of Alabama in 1993; and

WHEREAS, Lieutenant Hill worked many hours in the field of Interstate Highway Narcotic Interdiction, resulting in hundreds of narcotic arrests and prosecutions; and

WHEREAS, Lieutenant Hill was promoted to the rank of Corporal in 2000 and assigned to the Patrol division; and

WHEREAS, Lieutenant Hill was promoted to the rank of Sergeant in 2004 and was reassigned from the Patrol division to the Special Operations Unit (SOU); and

WHEREAS, Lieutenant Hill was promoted to the rank of Lieutenant in 2007 and was reassigned from the Special Operations Unit (SOU) back to the Patrol division; and

WHEREAS, Lieutenant Hill graduated the Federal Bureau of Investigation's National Academy (FBINA) in 2007; and

WHEREAS, Lieutenant Hill was reassigned to the Civil division as Lieutenant until 2020 where he was then reassigned to the Judicial Protective Services (JPS); and

WHEREAS, Lieutenant Hill served under two Sheriffs of Baldwin County: Sheriff James B. Johnson, and Sheriff Huey "Hoss" Mack; and

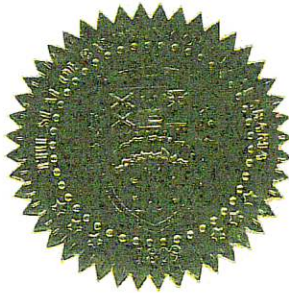
