Foley, husband & wife, have this day bargained and sold, and by these presents do hereby GRANT, BARGAIN, SELL and CONVEY unto Baldwin County, Alabama, the following described property:

**A part of the East Half of the Northwest Quarter of the Southeast Quarter of Section 32, Township 6 South, Range 5 East, identified as Tract Number 3 on Bemis Lane, Project No. 0221319 in Baldwin County, Alabama and being more fully described as follows:**

**Parcel 1 of 1:**

Commencing at a railroad spike found at the southeast corner of the Southeast Quarter of Section 32, Township 6 South, Range 5 East, in Baldwin County, Alabama;




