RESOLUTION #2021-038 OF THE BALDWIN COUNTY COMMISSION

PURSUANT TO THE AUTHORITY FOUND AT SECTION 45-2-241 OF THE <u>CODE OF ALABAMA</u> 1975, AND RELATED TO THE REVENUE COMMISSIONER OF BALDWIN COUNTY, ALABAMA, TAKING OFFICE ON FEBRUARY 2, 2021, FIXING THE SUM OF SAID COUNTY OFFICIAL'S BOND AND SETTING THE EXACT AMOUNT OF THE COMPENSATION TO BE PAID TO SAID COUNTY OFFICIAL.

WHEREAS, Section 45-2-241 of the <u>Code of Alabama</u> 1975 (Code) provides for the establishment of the Office of Revenue Commissioner of Baldwin County, Alabama (Revenue Commissioner); and

WHEREAS, the Code requires the Baldwin County Commission to set the sum of the bond held by said Revenue Commissioner, said bond's cost to be paid out of the General Fund of Baldwin County on a warrant of the Baldwin County Commission which shall be a preferred claim against Baldwin County; and

WHEREAS, further, the Code requires, and prior to the Revenue Commissioner taking office, that the Baldwin County Commission set the exact amount of said county official's annual compensation payable in a manner prescribed by said Baldwin County Commission out of the General Fund of Baldwin County; and

WHEREAS, a new Revenue Commissioner, the Honorable Teddy J. Faust Jr., will take office on February 2, 2021, for a six year term of office expiring February 2, 2027.

COMES NOW, the Baldwin County Commission, pursuant to the authority provided by the Code and related to the Revenue Commissioner taking office on February 2, 2021, desiring to set the sum of the bond held by said Revenue Commissioner and, further, set the exact amount of said Revenue Commissioner's annual compensation payable in a manner prescribed by the Baldwin County Commission; now therefore

BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED, that, pursuant to the authority found at Section 45-2-241 of the <u>Code of Alabama</u> 1975 and related to the Revenue Commissioner of Baldwin County, Alabama, taking office on February 2, 2021 the Honorable Teddy J. Faust, Jr., it is hereby authorized as follows:

- The Bond of the Revenue Commissioner of Baldwin County, Alabama is fixed in the sum of \$750,000 with the Clerk/Treasurer of Baldwin County instructed to pay the cost of said bond out of the General Fund of Baldwin County; and
- 2. The Compensation of the Revenue Commissioner of Baldwin County, Alabama, is set in the exact amount of \$110,000 annually and payable biweekly out of the General Fund of Baldwin County.
